By Alderman Morris. An ordinance appropriating that part of the General Revenue taxes levied for the year A. D. 1898 and on account of General Revenues of the present fiscal year to provide for the payment of the second installment of the judgment recovered against the City of Austin by E. C. Bartholomew, Receiver, in the United States Circuit Court for the Western District of Texas on the 11th day of March A. D. 1896. Read and on motion laid over until Tuesday evening.

Alderman Dittmer, by permission, presented a petition from A. S. and Co. Corwin, asking for the use of two of the City teams with certain tools to open up street recently, deeded to the City by John W. Maddox and wife, the petitioners to furnish and pay for drivers and labor. On motion the petition was granted.

Act. of S. C. Loew asking for remission of part of fine assessed against Sidney Loew in Recorder's Ct.

Said Mayor laid before the Council a petition from S. C. Loew, asking remission of a part of the fine assessed in the Recorder's Court against Sidney Loew.

Said petition was recommended by the Recorder and the Mayor, and on motion the petition was granted.

Adjourned until Tuesday March 8th 1898 at 8. 1/2 m.

Minutes of an adjourned Regular Meeting of the City Council.

Alderman Crocker moved a call of the Council, which was seconded.
Roll called.

The Marshal was directed to bring in the absentees.

Ex-Mayor Hancock invited to address meeting.

Upon motion of Alderman Maddox, ex-Mayor Hancock, who was present was invited to address the Council upon the matter of the settlement of the judgment of E. C. Bartholomew, Receiver, against the City.

Ex-Alderman Linn invited to address meeting.

Mr. Hancock addressed the Council, after which ex-Alderman Linn, by invitation, addressed the Council on the same subject.

Aldermen Delvin, Miller, Pead, Robertson and Zilker entered the Council Chamber.

Aldermen Fischer & McLenore excused.

Alderman Robertson moved to excuse Aldermen Fischer & McLenore, which motion prevailed by the following vote.

Alderman Morris moved to suspend the call of the Council, which motion prevailed.

Alderman Maddox moved that the pending business be suspended for the present. Adopted.

Budget for Fiscal year ending Nov. 30 1898 adopted July 23rd 1898. Amended.

Alderman Morris moved that the budget adopted by the Council on the 23rd day of February, 1898, be amended by adding to it the following: "To pay the first installment and interest due on same upon the judgment recovered against the City of Austin by E. C. Bartholomew, Receiver, etc." which motion prevailed.

Special Com. appointed to prepare substitute for Ord. now pending.

On motion of Alderman Powell, Aldermen Morris, Maddox, Platt and Taylor, together with the City Attorney, and the Mayor, were appointed a committee to prepare a substitute to the ordinance under consideration to meet the views of a majority of the Council present.

On motion of Alderman Delvin, the Council took a recess of ten minutes to allow the committee to prepare and present their report.

After the recess, the Council was called to order.
