Austin, Texas, June 25<sup>th</sup> 1898.

Roll called.

Minutes of an adjourned called Meeting of the City Council.  
Austin, Texas, July 27<sup>th</sup> 1898.

Hon. Geo. D. McCall, Mayor, presiding.

Roll called.

Present. Aldermen Beatty, Belvin, Crocker, Haynes, Horton, Kuhn, Miller, Platt, Powell, Redd, Rosengren, Shelley, Taylor and Townsend 14.

Absent. Aldermen Fischer, Maddox, McSquire, Morris, Nitschke, Robertean, Stumpf and Silver 8.

The Mayor laid before the Council an ordinance appropriating the sum of \$15,500 to pay interest due July 1<sup>st</sup> 1898, on bonds issued prior to May 1<sup>st</sup> 1890. The ordinance was read the third time and placed upon its final passage, and was lost by the following vote:

Ayes. Aldermen Haynes, Horton, Kuhn, Powell, Redd, Rosengren, Shelley, Taylor and Townsend 9.

Nays. Aldermen Beatty, Belvin, Crocker, Miller and Platt 5.

Alderman Shelley moved to reconsider the vote just had, by which the Council refused to pass the ordinance, which motion prevailed.

On motion the City Attorney was asked to advise the Council as to the validity of the bonds mentioned in the ordinance which he did, after which, the Council, on motion of Alderman Belvin, adjourned.
