Alderman Dunham moved to amend the ordinance by filling in the  
first blank the word "Ninety" thus making the levy of taxes for general  
purposes ninety cents on the \$100.<sup>00</sup> The amendment was adopted.

Alderman Dunham moved to amend by inserting in the second blank  
the words one hundred, thus making the amount levied to pay interest  
and sinking fund Water Light bonds one dollar on the \$100.<sup>00</sup> The  
Amendment was adopted.

Alderman Dunham moved amend by  
inserting in the third blank the word "seven" thus making the levy  
for interest and sinking fund on refunding bonds seven cents on the \$100.<sup>00</sup>

one third" thus making the amount levied for Public Freedchore
