New Business

The Mayor laid before the Council the bill of the Austin Water Works & Electric Light Plant for water & light furnished the City to June 30 1899, which was read and on motion referred to the Water & Light Committee. He also laid before the Council a bill from the Austin Water Light & Power Co. for water claimed to have furnished the City for the six months ending June 30 1899, which was ordered filed.
