in fairly good shape and ordered the sanitary officer to continue dumping garbage there provided no fresh vegetable or animal matter be deposited and as much lime as necessary for disinfecting be used.

Minority  
report

The undersigned, a member of the Sanitary Committee to whom was referred a resolution requiring the City Health Officer to cease dumping garbage at the foot of Lavaca street, begs to submit that he is not able to agree with the report of the majority of this Committee; as in his opinion the present manner of depositing garbage at said place is offensive to those residing and doing business in this neighborhood, and would suggest that if said place is to be further used as a dumping ground, that the following precautions be taken:

First: A substantial rock wall should be built at the mouth of the gully so as to prevent the escape of garbage and filth into the river.

Second: When matter of an offensive nature is dumped on places in said gully there should be a constant and free use of disinfectants, to prevent the offensive stench that arises from this dump particularly at night when the air is humid and during and after a rain.
