Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 185 firms on February 26, 2008. The RFQ was obtained by 31 firms, and five firms submitted qualification statements. One of the firms is a certified M/WBE firm. Of the five firms evaluated, three firms were short-listed and interviewed. Interviewing of the short-listed firms results in the following recommendation.
