## EXHIBIT "A"

DESCRIPTION OF 0.1723 OF ONE ACRE OF LAND SITUATED IN THE SAMUEL HAMILTON SURVEY NO. 16, IN TRAVIS COUNTY, TEXAS, BEING A PORTION OF THAT CERTAIN CALLED 261.446 ACRE TRACT DESCRIBED IN SPECIAL WARRANTY DEED TO THE CITY OF AUSTIN, EXECUTED AUGUST 28, 1998, RECORDED IN VOLUME 13258, PAGE 1543, REAL PROPERTY RECORDS OF TRAVIS COUNTY, TEXAS, (R.P.R.T.C.TX); SAID 0.1723 OF ONE ACRE OF LAND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a 1/2" iron rod found in the east right-of-way line of State Highway No. 45 (R.O.W. varies) for the southwest corner of the tract described herein having coordinates of N(Y) = 10,035,048.26 ft., E(X) = 3,069,764.88 ft., NAD83/HARN/CORS Texas Central Zone, said point being the southwest corner of said 261.446 acre tract and the northwest corner of that certain called 49.315 acre tract described in a Special Warranty Deed with Vendor's Lien to Wildflower Commons II, L.P., executed June 9, 2006, recorded under Document No. 2006111840 of the Official Public Records of Travis County, Texas (O.P.R.T.C.TX.), the northeast corner of that certain called 13.845 acre tract described in deed to MoPac South Transportation Corporation, executed March 24, 1988, recorded in Volume 10719, Page 920, R.P.R.T.C.TX., and the southeast corner of that certain called 85.033 acre tract described in a General Warranty Deed to MoPac South Transportation Corporation, executed March 24, 1988, recorded in Volume 10719, Page 926, R.P.R.T.C.TX.;

THENCE with the west line of said 261.446 acre tract, the east line of said 85.033 acre tract, and the east right-of-way line of State Highway No. 45, with the arc of a curve to the right a distance of 149.92 feet, said arc having a radius of 1000.00 feet and a chord which bears N10°17'17"E a distance of 149.78 to a 5/8" iron rod with LCRA aluminum cap set for the northwest corner of the tract described herein, same point being in the north line of an Easement Agreement to Gary L. Bradley, Trustee, executed January 1, 1988, recorded in Volume 10643, Page 505, R.P.R.T.C.TX., from which a 1/2" iron rod found for the point of tangency of said curve bears N21°45'41"E a chord distance of 249.45 feet;

**THENCE** with the north line of said Easement Agreement, over and across said 261.44 acre tract, N87°34'01"E a distance of 52.42 feet to a calculated point for the northeast corner of the tract described herein, from which a 5/8" iron rod with LCRA aluminum cap set for reference bears N87°34'01E a distance of 2.91 feet;

THENCE continuing across said 261.446 acre tract, 50.00 feet from and parallel with the west line of this tract, with the arc of a curve to the left a distance of 150.37 feet, said curve having a radius of 950.00 feet and a chord which bears \$10°58'25"W a distance of 150.21 feet to a calculated point for the southeast corner of the tract described herein, in the south line of said 261.446 acre tract, the south line of said Easement Agreement, and the north line of said 49.315 acre tract, from which a 5/8" iron rod with LCRA aluminum cap set for reference bears N87°34'59"E a distance of 2.77 feet, and also from which a 1/2" iron rod found at an angle point in the south line of said 261.446 acre tract for the northeast corner of said 49.315 acre tract bears N87°34'59"E a distance of 1893.07 feet and N87°38'45"E a distance of 436.67 feet;

**THENCE** with the south line of said 261.446 acre tract and the north line of said 49.315 acre tract, S87°34'59"W a distance of 50.57 feet to the **POINT OF BEGINNING** and containing 0.1723 of one acre of land within these metes and bounds.

BEARING BASIS: All bearings are based on the Texas Lambert Grid, NAD83/HARN/CORS Central Zone.
