Memorandum To:

Mayor Pro Tem Trevino called to order the Special Called Meeting of the Council, noting the absence of Mayor Mullen and Councilmember Spaeth. Mayor Pro Tem Trevino announced the purpose of the meeting is to consider adopting a resolution canvassing the returns and declaring the results of the September 8, 1984 Municipal Bond Election.

Councilmembers studied ballot returns and reported as follows:

Councilmember Duncan stated Precinct 324 had a discrepancy of 40 ballots. Jeff Gunter, Chief Election Judge told Council the Precinct Judge erred on the ballot seal and certificate. Councilmember Duncan noted that Precincts 326, 325, 324 and 323 checked out all right.

Councilmember Urdy said there was a discrepancy of 2 votes in Precinct 347. Mr. Gunter said the the discrepancy could not be resolved. Councilmember Urdy said Precinct 346 checks.

Mayor Pro Tem Trevino said Precincts 150, 149, 148 and 147 are all right.

Councilmember Rose said Precints 133 and 136 are all right.

A RESOLUTION by the City Council of the City of Austin, Texas, canvassing returns and declaring the result of a bond election held in said City on the 8th day of September, 1984.

WHEREAS, this governing body ordained that an election be held within this City on the 8th day of September, 1984, for the purpose of submitting certain propositions for the issuance of bonds to the resident electors of the City; and,

WHEREAS, it is hereby found and determined that said election was held in accordance with the authorizing proceedings, that notice of the election was duly given in the form, manner and time required by law, and that said election was in all respects legally held and conducted in accordance with the laws of the State of Texas applicable thereto; and,

WHEREAS, the returns of the said election have been made to this governing body and said returns, duly and legally made, show the following votes were cast on the propositions submitted at said election, to-wit:

SECTION 1: That all of the recitals contained in the preamble of this resolution are found to be true and are adopted as findings of fact by this governing body and as part of its judgment.

It is further found and determined that the SECTION 2: results of the election as canvassed and tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.

That a majority of the resident qualified SECTION 3: electors voting at said election having voted in favor of Propositions Numbers 1-28, the City Council of said City is authorized and empowered to issue bonds on behalf of said City in the amounts and for the purposes prescribed in Propositions Numbers 1-28 in the proceedings calling the election.
