ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO AMEND OR ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY KOENIG LANE, NORTH LAMAR BOULEVARD, AIRPORT BOULEVARD, AND 51ST STREET.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to read:

Avenue F from 38th Street (East) [51st Street (East)] to Skyview Road (East).

Avenue G from 45th Street (East) to 56th Street (East) [51st Street (East)].

Avenue H from 38th Street (East) to <u>56th Street (East)</u> [51st Street (East)].

Caswell Avenue from <u>Park Boulevard</u> [42nd <u>Street (East)</u>] to <u>Clarkson Avenue</u> [51st <u>Street (East)</u>].

Chesterfield Avenue from North Loop Boulevard (West) [Koenig Lane (West)] to Skyview Road (West).

Clarkson Avenue from Bennett Avenue to <u>Bruning Avenue</u> [51st Street (East)].

Eilers Avenue from 50th Street (East) to <u>Bruning Avenue</u> [51st Street (East)].

Evans Avenue from 50th Street (East) to the north end of Evans Avenue [51st-Street (East)].

Martin Avenue from 50th Street (East) to the north end of Martin Avenue [51st Street (East)].

PART 2. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

52nd Street (East) from Clarkson Avenue to the end of 52nd Street (East).

54th Street (East) from Link Avenue to Middle Fiskville Road.

1	55 th Street (East) from Link Avenue to Evans Avenue.
2	56 th Street (East) from Link Avenue to Avenue F.
3	55 th Street (West) from Link Avenue to Guadalupe Street.
4	55 th ½ Street (West) from Link Avenue to Guadalupe Street.
5	56 th Street (West) from Link Avenue to Chesterfield Avenue.
6	Bruning Avenue from Duval Street to Clarkson Avenue.
7	Franklin Boulevard from Lamar Boulevard (North) to Link Avenue.
8	Genard Street from Huisache Street to Leralynn Street.
9	Guadalupe Street from Zennia Street to Koenig Lane (West).
10	Huisache Street from Zennia Street to North Loop Boulevard (West).
11	Leralynn Street from 51 st Street (West) to North Loop Boulevard (West).
12	Link Avenue from Franklin Boulevard to 56 th Street (West).
13	Nelray Boulevard from Lamar Boulevard (North) to Link Avenue.
14	Zennia Street from Lamar Boulevard (North) to Leralynn Street.
15 16 17 18 19	PART 3. The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Parts 1 and 2 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.
20 21	PART 4. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.
