SUBJECT:

The Water and Wastewater Commission recommends authorization to award, negotiate, and execute an 18-month requirements supply and service contract with **CUES, INC.**, Orlando, FL, for the purchase and installation of closed circuit television software and software maintenance and support in an estimated amount not to exceed \$319,031, with three 12-month extension options in estimated amounts not to exceed \$272,972 for the first extension option, \$26,600 for the second extension option, and \$26,600 for the third extension option, for a total estimated contract amount not to exceed \$645,203.
