 repealing ordinance

 on \$320,000 "water
 & light bonds"

By Alderman Haynes, an ordinance to repeal an
 ordinance entitled "an ordinance appropriating
 the sum of four thousand dollars for the purpose of
 paying interest due Oct 1st 1906; on three hundred
 and twenty thousand dollars, water and light bonds,"
 approved Sept 26, 1906, and to cancel any warrant
 drawn in virtue thereof. The ordinance was read the
