ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY WILLIAM CANNON DRIVE, MARBLE CREEK PROPER, ONION CREEK PROPER, AND THE CURRENT AUSTIN CITY BOUNDARY LINE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Ada Court from Dixie Drive to the end of Ada Court.

Alum Rock Drive from Panadero Drive to the end of Alum Rock Drive.

Antoine Circle from Lake Charles Drive to the end of Antoine Circle.

Bannock Lane from Roseborough Drive to Ken Caryl Drive.

Bixler Drive from Tupelo Drive to the end of Bixler Drive.

5 Bramble Bush Drive from Thaxton Road to Roseborough Drive.

7 Briarton Drive from Forbsdale Drive to Thaxton Road.

Broad Brook Drive from Alum Rock Drive (north intersection) to Alum Rock Drive (south intersection).

Bumpstead Drive from Panadero Drive to Ipswich Bay Drive.

2 Cats Eye Lane from Marble Ridge Drive to Tara Drive.

Conti Court from Dixie Drive to the end of Conti Court.

Crepe Myrtle Drive from Springtime Trail to Zequiel Drive

Deridder Court from Rhett Place to the end of Deridder Court.
