Contract and Land Management RECOMMENDATION FOR COUNCIL ACTION

Subject: Authorize negotiation and execution of an amendment to the professional services agreement with THE BROUSSARD GROUP, INC., DBA TBG Partners, a Texas corporation, Austin, Texas for Design Services for the redevelopment of Auditorium Shores in the amount of \$402,930 for a total authorization amount not to exceed \$2,100,242.

Amount and Source of Funding: Funding in the amount of \$402,930 is available in the Fiscal Year 2008-2009 Capital Budget of the Parks and Recreation Department.

MBE/WBE: This contract will be awarded in compliance with Chapter 2-9B of the City Code (Minority Owned and Women Owned Business Enterprise Procurement Program) with 20.35% MBE and 20.35% WBE subcontractor participation to date.

This amendment represents the implementation of the final phase of the original Town Lake Park Master Plan. The original master plan completed by EDAW Inc. in 1999 included four phases: Phase I - Palmer Auditorium & Long Center; Phase II - Butler Park, south of Riverside Drive; and Phase III & IV will include the parkland north of Riverside Drive.

The Broussard Group (TBG) has completed the construction designs for the first two phases of the project and is recommended to complete the last phase. Their work on the project began in 1999 and has continued through the fall of 2008 with the conclusion of Phase 2. Their work has included extensive interaction with stakeholders and the surrounding community. Because of TBG's in-depth knowledge of the physical site and their understanding of the community dynamics involved in design decisions, their continued work on the final phase of this important project is essential to its successful completion. It has been determined that it is in the best interest of the project to retain the continued services of TBG for this final phase.

This contract will provide design services for the redevelopment of Auditorium Shores from schematic design through the preparation of construction documents. This project area is located between Lady Bird Lake to the north, Riverside Drive to the south, South 1st Street to the east and the Union Pacific railroad bridge to the west. This project will complete the redevelopment of the historically known Town Lake Park area.

It is anticipated that the design work will start in early 2009 and will be completed by the fall of 2009.
