

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 331 firms on April 30, 2008. The RFQ was obtained by 135 firms, and 22 firms submitted qualification statements. None of the firms were certified M/WBE firms. Of the 15 firms evaluated, six firms were short-listed and interviewed. These short-listed firms made presentations to the Austin City Council on October 23, 2008. Interviewing of the short-listed firms results in the following recommendation:

Participation subgoals stated in the solicitation were 1.70% African American; 9.50% Hispanic; 5.30% Native / Asian and 14.20% WBE.
