

ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-64(D) OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR ON CERTAIN STREETS WITHIN THE AREA BOUNDED BY THE CURRENT AUSTIN CITY BOUNDARY LINE PARALLELING BEE CAVES ROAD, LOOP 1, (MOPAC EXPRESSWAY) (SOUTH) WEST SERVICE ROAD, LOOP 360 (CAPITAL OF TEXAS HIGHWAY) (SOUTH), AND THE CURRENT AUSTIN CITY COUNDRARY LINE PARALLELING WALSH TARLTON LANE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-64(D) (*Table of Speed Limits*) of the City Code is amended to add the following street sections with 25 mile per hour speed limits:

Angelfire Lane from Crested Butte Drive to the end of Angelfire Lane.

Aquifer Cove from Terrapin Court to the end of Aquifer Cove.

Beecave Woods Drive from Honey Tree Lane to the current Austin city boundary line.

Breeze Knoll Circle from Eanes Circle to the end of Breeze Knoll Circle.

Brians Meadow Cove from Wilderness Drive to the end of Brians Meadow Cove.

Brightwood Drive from Eanes Circle (east intersection) to Eanes Circle (west intersection).

Cactus Wren Way from Dusky Thrush Trail to the end of Cactus Wren Way.

Capital Parkway from Loop 1 (Mopac Expressway) (South) West Service Road to the end of Capital Parkway.

Cetona Court from Stoneridge Road to the end of Cetona Court.

Chatelaine Cove from Chatelaine Drive to the end of Chatelaine Cove.

Chicory Cove from Wilderness Drive to the end of Chicory Cove.

4 Tamranae Court from Havre Lafitte Drive to the end of Tamranae Court.

5 Tarlton Cove from Tarlton Lane to the end of Tarlton Cove.

6 Tarlton Lane from Walsh Tarlton Lane to the current Austin city boundary line.

7 Terrapin Court from Walsh Tarlton Lane to the end of Terrapin Court.

8 Texas Star Lane from Walsh Tarlton Lane to the end of Texas Star Lane.

9 Thousand Oaks Circle from Thousand Oaks Drive to the end of Thousand Oaks

12 Thousand Oaks Cove from Walsh Tarlton Lane the end of Thousand Oaks Cove.

13 Treemont Drive from Chatelaine Drive to the current Austin city boundary line.

14 Twinberry Cove from Walsh Tarlton Lane to the end of Twinberry Cove.

15 Wilderness Cove from Wilderness Drive to the end of Wilderness Cove.

16 Winter Park Road from Holly Hill Drive to Intervail Drive.

17 Wychwood Drive from Apricot Glen Drive (south intersection) to Apricot Glen
18 Drive (north intersection).

20 **PART 2.** The City Council finds that the prima facie speed limit previously applicable to
21 the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or
22 unsafe, and the reduction in speed limit on these streets will reduce the potential for
23 vehicle-pedestrian accidents.

25 **PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical
26 order and the existing subsections renumbered accordingly.
