July 10th 1876

The Council was called to order at 12:15 o'clock
Wm. F. Bhaudler President of the Board in the Chair

Roll called and the following members answered,
Alderman Cook, Duffenbaugh, Goodale, Robinson Shuts and Taylor. Absent Alderman Bremond, James and Larmon

The President informed the Council that the object in calling them together was to take action on a Petition presented from the Houston and Texas Central Railroad Company asking the granting of permission to erect a shed or covering for their Pullman Palace Sleeping Coaches, on the line of their railroad track between the Passenger platform and the public square, whereupon Alderman Cook introduced the following

Resolved that the petition asked for by the Central Railroad Company be granted, provided said Company complies with the ordinances regulating such matters.

Yeas and Nays ordered and the resolution passed by the following vote. Yeas Alderman Cook, Duffenbaugh, Goodale and Taylor. Nays Alderman Robinson and Shuts

By Alderman Taylor Resolved by the City Council of the City of Austin that the Mayor be authorized to have printed 1000 burial certificates for the use of the City Sexton

On motion of Alderman Shuts the resolution was laid on the table

On Motion of Alderman Shuts the resolution was taken from the table and passed

By Alderman Taylor Resolved by the City Council of the City of Austin That the Mayor be and is hereby authorized to purchase from M. D. Mather a Drinking Fountain and have the same located on Block #124 Cor of Mesquite and Congress Avenue Streets. That the cost of said Fountain shall not exceed the sum of \$165.00 and that the Streets Committee be empowered to have said Fountain erected at the point designated, and that the City pay for the use of water at the same rates as is paid for Street Hydrants

The President of the board asked to be excused from presiding on the grounds of being interested in the City Water Company Excused

On Motion of Alderman Shuts. Alderman Taylor was called to the Chair

Alderman Shuts moved a Call of the House
Call sustained

Roll called and the following members answered

On Motion Shuts the call was suspended and the resolution for the purchase of water Fountain was taken up
