The Water and Wastewater Commission recommends authorization to negotiate and execute an amendment to the professional services agreement with **LOCKWOOD, ANDREWS & NEWMAN, INC.**, Austin, Texas, for fee adjustment for Supplemental Agreement 3 for remaining post-bid and construction phase services in the amount of \$7,860; bid phase (rebid) services for the 2004 Valve Replacement Program, in an amount of \$13,282; and a contingency of \$5000 in an amount not to exceed \$26,142; for a total agreement, including administratively approved Supplemental Amendment 2 for additional design services in the amount of \$30,704.42, not to exceed \$477,441.
