

Bid documents were distributed to twenty nine general contractors. Bids were opened on February 5, 2009. Smith Contracting Company, Inc. submitted the lowest bid of five bids received:

The contractor's choice of work methodology provides for four areas of subcontracting opportunities: permanent erosion controls and landscaping, site fencing, and two firms for trucking and hauling services.

Project participation subgoals stated in the solicitation were 3.15% African American, 10.42% Hispanic, 0.30% Native/Asian, and 2.40% WBE. Total participation estimated on base bid amount of \$540,791.00:
