

Bid documents were distributed to 20 general contractors. Bids were opened on February 12, 2009. Capitol Concrete Contractors submitted the lowest of 11 bids received. During the bid evaluation, Capitol Concrete Contractors requested that their bid be withdrawn. The low bidder became Jo'B Site Construction, LLC:
