

Participation subgoals stated in the solicitation were 1.70% African American; 9.50% Hispanic; 5.30% Native / Asian ; 14.20% WBE. The recommended firm provided an M/WBE Compliance Plan that met the goals of the solicitation and was approved by the Department of Small and Minority Business Resources. The alternate firm provided an M/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 303 firms on November 14, 2008. The RFQ was obtained by 68 firms, and four firms submitted qualification statements. None of the firms were certified M/WBE firms. Of the four firms evaluated, four firms were short-listed and interviewed. Interviewing of the short-listed firms results in the following recommendation:
