AN ORDINANCE REZONING AND CHANGING THE ZONING MAP TO ADD A VERTICAL MIXED USE BUILDING (V) COMBINING DISTRICT TO CERTAIN TRACTS OF LAND LOCATED IN THE EAST CESAR CHAVEZ NEIGHBORHOOD PLANNING AREA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to add a vertical mixed use building (V) combining district to certain tracts of land (the "Property") described in Zoning Case No. C14-2009-0036, on file at the Neighborhood Planning and Zoning Department, as follows:

Approximately 2.39 acres of land in the City of Austin, Travis County, Texas, more particularly described and identified in the tract map attached as Exhibit "A" (East Cesar Chavez Neighborhood Planning Area),

located in the East Cesar Chavez neighborhood planning area, locally known as the area bounded by the alley between East 6th Street and East 7th Street on the north, Chicon Street on the east, Lady Bird Lake on the south, and IH-35 on the west, in the City of Austin, Travis County, Texas, and identified in the map attached as Exhibit "B" (the Zoning Map).

Except as provided in this ordinance, the existing base zoning districts and conditions remain in effect.

PART 2. The zoning districts for the tracts of land are changed from general commercial services-mixed use-conditional overlay-neighborhood plan (CS-MU-CO-NP) combining district, and community commercial-mixed use-conditional overlay-neighborhood plan (GR-MU-CO-NP) combining district, to general commercial services-mixed use-vertical mixed use building-conditional overlay-neighborhood plan (CS-MU-V-CO-NP) combining district, and community commercial-mixed use-vertical mixed use building-conditional overlay-neighborhood plan (GR-MU-V-CO-NP) combining district, as more particularly described and identified in the chart below:



PART 3. The Property is subject to Chapter 25-2, Subchapter E, Article 4.3 (Vertical Mixed Use Buildings) as follows:

- A. Ten percent of residential units available for rental in a vertical mixed use building shall be reserved for households earning no more than 60 percent of the Annual Median Family Income.
- B. The property is exempt from the dimensional standards identified in Article 4.3.3 E.2. (Dimensional and Parking Requirements).
- C. For property in office districts, the additional uses allowed under Article 4.3.3. C.2 (Ground-Floor Commercial Uses Allowed) apply.


