

ORDINANCE NO. 20090611-015

AN ORDINANCE AMENDING THE FISCAL YEAR 2008-2009 EMERGENCY MEDICAL SERVICES DEPARTMENT FEE SCHEDULE OF ORDINANCE 20080908-006 TO APPROVE CHANGES TO THE EMERGENCY MEDICAL SERVICES FEES FOR GROUND PATIENT TRANSPORTS AND MILEAGE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:


