story houses which characterize the neighborhood and this potential historic district. The newest houses reflect today's materials in siding and fenestration – hardi-plank prevails in exterior siding materials, and vinyl windows appear in some of the newer houses.

Of the 89 houses (including the duplex addition to 108 E. 48<sup>th</sup> Street, with its own address of 4800 Avenue F),

**55** (61.8%) are preliminarily determined to be CONTRIBUTING to the historic character of the potential district;

1 may be determined contributing after the completion of additional research to determine its age and integrity of materials;

2 (4810 Rowena and 4909 Avenue F) could be determined contributing with the removal of vinyl siding and restoration of the original wood siding on the house; 31 (34.8%) are considered to be NON-CONTRIBUTING to the historic character of the district, either because of a modern date of construction or non-historic alterations which have significantly altered the historic appearance of the house. In determining houses which are non-contributing because of modifications, we have determined that the application of a synthetic siding material would not allow for a determination that the house in its current state would be contributing to the historic character of the district, but that the alteration could be removed and original historic fabric restored. Houses which have lost historic fabric through the replacement of window or other materials have been determined non-contributing in this survey and evaluation because of the lost historic fabric.
