

Participation subgoals stated in the solicitation were 1.7% African American; 9.5% Hispanic; 5.3% Native/Asian; 14.2% WBE. The recommended and alternate firm both provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 266 firms on December 5, 2009. The RFQ was obtained by 53 firms, and nine firms submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the nine firms evaluated, two firms were short-listed and interviewed. Interviews with the short-listed firms results in the following recommendation.
