

Participation subgoals stated in the solicitation were 1.9% African American; 9.0% Hispanic; 4.9% Native/Asian; and 15.8% WBE. The recommended and alternate firms provided a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 278 firms on April 10, 2009. The RFQ was obtained by 48 firms, and 14 firms submitted qualification statements. Two of the firms were certified MBE/WBE firms. Of the number 14 firms evaluated, five firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following recommendation:
