The Water and Wastewater Commission recommends authorization to award and execute six contracts through the Texas Local Government Purchasing Cooperative (BuyBoard) with: **RDO EQUIPMENT CO.**, Pflugerville, TX for the purchase of three articulated wheeled loaders, 10 tractor/loader/backhoes, two skid steer loaders, and two hydraulic excavators in an amount not to exceed \$1,899,996.76; **VERMEER OF TEXAS**, Round Rock, TX for the purchase of one tub grinder in an amount not to exceed \$626,650; **TYMCO INTERNATIONAL, LTD**, Waco, TX for the purchase of one street sweeper in an amount not to exceed \$79,397.50; **COOPER EQUIPMENT CO.**, San Antonio, TX for the purchase of three low bed equipment trailers and one motor grader in an amount not to exceed \$351,116.90; **KINLOCH EQUIPMENT & SUPPLY, INC.**, Arlington, TX for the purchase of two street sweepers in an amount not to exceed \$324,660; and **HOLT CAT**, Austin, TX for the purchase of one articulated wheeled loader in an amount not to exceed \$300,010.
