
SUBJECT:

The Water and Wastewater Commission recommends authorization to award and execute a 24-month requirements supply contracts for couplings and inserts with **FERGUSON WATERWORKS**, Georgetown, TX, in an amount not to exceed \$170,368 with two 12-month extension options in an amount not to exceed \$85,184 per extension option, for a total contract amount not to exceed \$340,736; with **MUNICIPAL WATER WORKS**, Royse City, TX, in an amount not to exceed \$44,734 with two 12-month extension options in an amount not to exceed \$22,367 per extension option, for a total contract amount not to exceed \$89,468; with **HD SUPPLY WATERWORKS**, Round Rock, TX, in an amount not to exceed \$17,310 with two 12-month extension options in an amount not to exceed \$8,655 per extension option, for a total contract amount not to exceed \$34,620; and with **ACT PIPE & SUPPLY**, Pflugerville, TX, in an amount not to exceed \$10,656 with two 12-month extension options in an amount not to exceed \$5,328 per extension option, for a total contract amount not to exceed \$21,312.
