## RESOLUTION NO.

**WHEREAS**, the City of Austin (Issuer) is a home rule city authorized to issue obligations to finance its activities, the interest on which is excludable from gross income for federal income tax purposes (tax-exempt obligations) pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the Code); and

WHEREAS, the Issuer will make, or has made not more than 60 days before this date, expenditures related to construction projects to be completed by the City and reimbursed by Capital Metropolitan Transportation Authority as described in Interlocal Agreements between the City of Austin and Capital Metropolitan Transportation Authority, including 2001, 2003 and 2005 Interlocal Agreements and any future amendments to these Agreements, which set forth programs known as the "Quarter Cent" and "Build Central Texas" programs.

**WHEREAS**, the Issuer intends to expend available moneys, including moneys on deposit in the Issuer's general fund, for these expenditures; and

**WHEREAS**, the Issuer has concluded that it does not currently desire to issue tax-exempt obligations to finance these expenditures; and

WHEREAS, the Issuer finds, considers and declares that the reimbursement of the payment by the Issuer of these expenditures will be appropriate and consistent with the lawful objectives of the Issuer and chooses to declare its intention, in accordance with the provisions of Section 1.150-2 of

the U.S. Treasury Regulations, to reimburse itself for such payments at such time as it issues tax-exempt obligations; and

WHEREAS, the Issuer reasonably expects to issue tax-exempt obligations to reimburse itself for expenditures made as described above; NOW, THEREFORE,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

The Issuer reasonably expects to reimburse itself for all costs that have been paid during the 60 days preceding this date or that will be paid after this date from the sale proceeds of tax-exempt obligations to be issued by or on behalf of the Issuer at a future date in an aggregate principal amount not to exceed \$30,000,000 for expenditures related to construction projects to be completed by the City and reimbursed by Capital Metropolitan Transportation Authority as described in Interlocal Agreements between the City of Austin and Capital Metropolitan Transportation Authority, including 2001, 2003 and 2005 Interlocal Agreements and any future amendments to these Agreements, which set forth programs known as the "Quarter Cent" and "Build Central Texas" programs; and

All costs to be reimbursed will be capital expenditures; the tax-exempt obligations shall be issued within 18 months of the later of (i) the date the expenditures are paid or (ii) the date on which the property, with respect to which such expenditures were made, is placed in service; and the tax-exempt
