SUMMARY STAFF RECOMMENDATION: The staff recommendation is to grant the change from GR-NP (Community Commercial – Neighborhood Plan) district zoning to P-NP (Public – Neighborhood Plan) zoning district.

SUMMARY PLANNING COMMISSION RECOMMENDATION: On October 13, 2009 Planning Commission voted to DENY staff's recommendation for P-NP zoning, was approved by Commissioner Jay Reddy's motion, Commissioner Danette Chimenti second the motion on a vote of 5-1. Commissioner Clint Small voted against the motion (nay); Commissioners Sandra Kirk and Dave Anderson were absent, with 1 vacancy on the Commission.

* The Commission recommended and voted unanimously for City Council to forward this case to the Mueller Commission.

(This case was postponed by the Neighborhood and Applicant on February 12, 2009; by the Neighborhood on February 24, 2009; by the Applicant on March 24, 2009 and an indefinite postponement was granted by the request of the Applicant on May 12, 2009; by the Neighborhood on August 11, 2009 and continued by the Planning Commission on September 22, 2009 – the public hearing remained open).

ISSUES: At the Planning Commission meeting of September 22, 2009, there was some discussion as to whether part of the 4.42-acre tract could maintain the current zoning of GR-NP and also be developed with commercial uses. Although the substation will occupy less than 2 acres of the site, Austin Energy requests a buffer between the substation and any commercial uses. Although the specific location of the substation on this tract has yet to be resolved, site constraints include the 35' drainage easement, floodplain, and the restriction that no permanent structures can be constructed under the power lines of the substation. Additionally, if the substation is permitted to build on the alternate site to the south, Austin Energy's power lines will still cross the current site, and no permanent structures could be constructed under these power lines.

On May 12, 2009, Austin Energy requested an indefinite postponement. The purpose of the indefinite postponement request was to allow additional time to consider an alternate site, and for Austin Energy to continue to meet with the neighborhood and other stakeholders. An alternate site was proposed by Austin Energy, however, all stakeholders did not support this proposition, so the applicant is moving forward with the original location. This case was re-noticed.

Austin Energy met with the Windsor Park Contact Team on February 9, the Robert Mueller Municipal Airport Plan Implementation Advisory Committee on March 10, and with the Mueller New Construction Council Team on March 11.

DEPARTMENT COMMENTS: The 4.42-acre site is currently zoned GR-NP (Community Commercial – Neighborhood Plan) district and is located at the northeast corner of Old Manor Road and E 51st Street. The proposed development will have driveway access from both streets, to which both ingress and egress access will be taken. The site lies within the University Hills/Windsor Park Combined Neighborhood Plan and is surrounded by Private Secondary Educational Facilities to the north, Communication Services to the south and multifamily to the east and west.

The subject property is currently undeveloped. Austin Energy, the property owner, is requesting P-NP, Public-Neighborhood Plan zoning to build a 138 kV substation by the summer of 2011. This substation is necessary to serve the redevelopment of Mueller (which includes the Dell Children's Hospital, offices, retail, and residential) and to solve other reliability issues in the surrounding area. The proposed substation will serve load within the 720 acre Mueller Redevelopment and the surrounding residential Windsor Park area. The applicant states that there will be a 10' tall concrete masonry wall and landscaping around the substation. Less than two acres will be used for the substation and the remainder will be left in its natural state.

The staff recommendation is to approve the requested zoning change because the proposed substation is 1) considered a civic use, and will provide electric service to the Mueller redevelopment and to the surrounding residential area of Windsor Park; 2) access is taken to an arterial and a collector street; and 3) it is the City Council's general policy that all City-owned or leased land be zoned Public (P) district.

In the P zoning district, any use on a site larger than one acre requires a conditional use site plan. The purpose of this requirement is to establish site development regulations such as building height, scale, setbacks and drainage. It also allows public comment at a hearing to ensure compatibility in terms of access, traffic circulation, bulk, open space and landscaping.

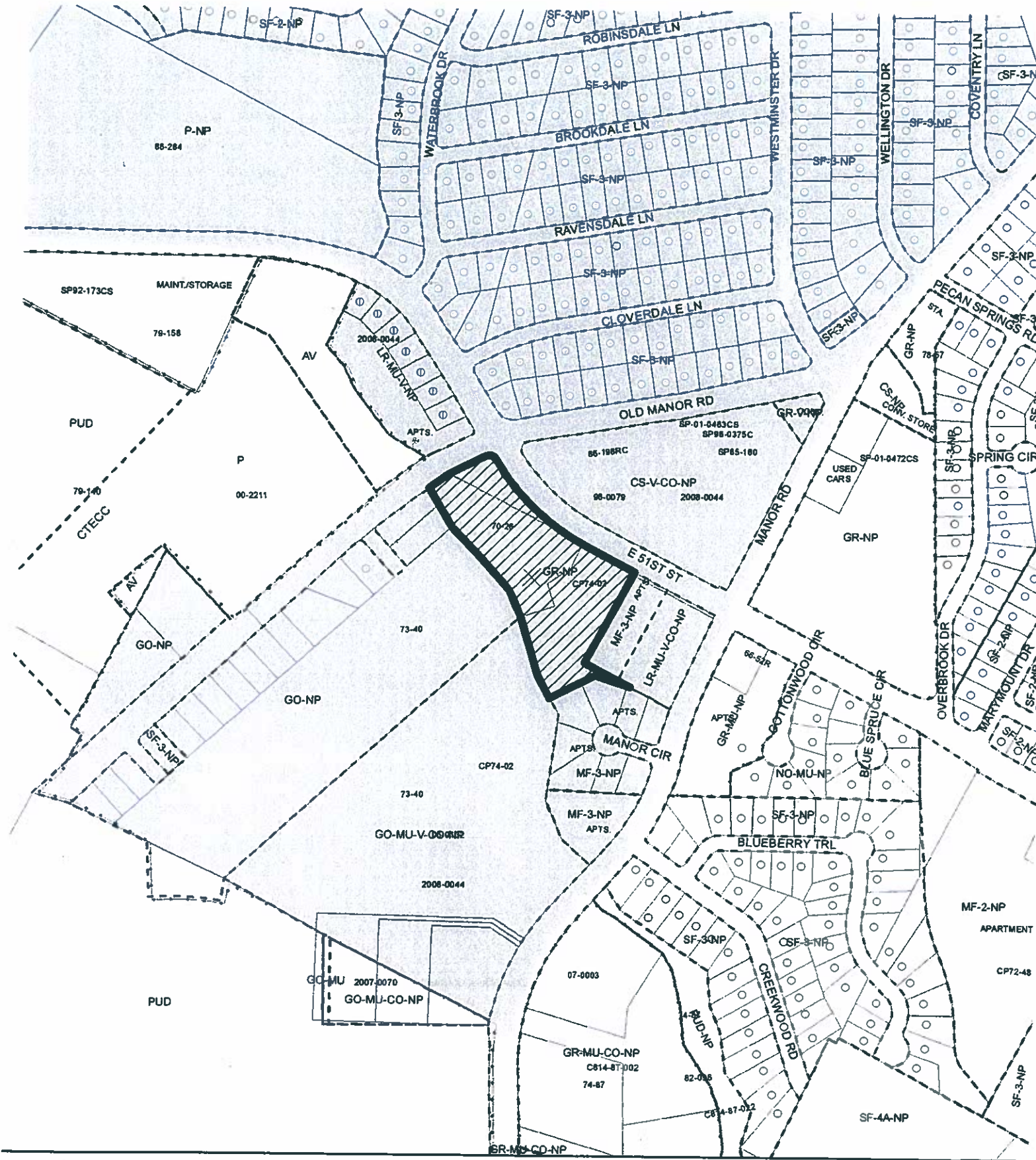

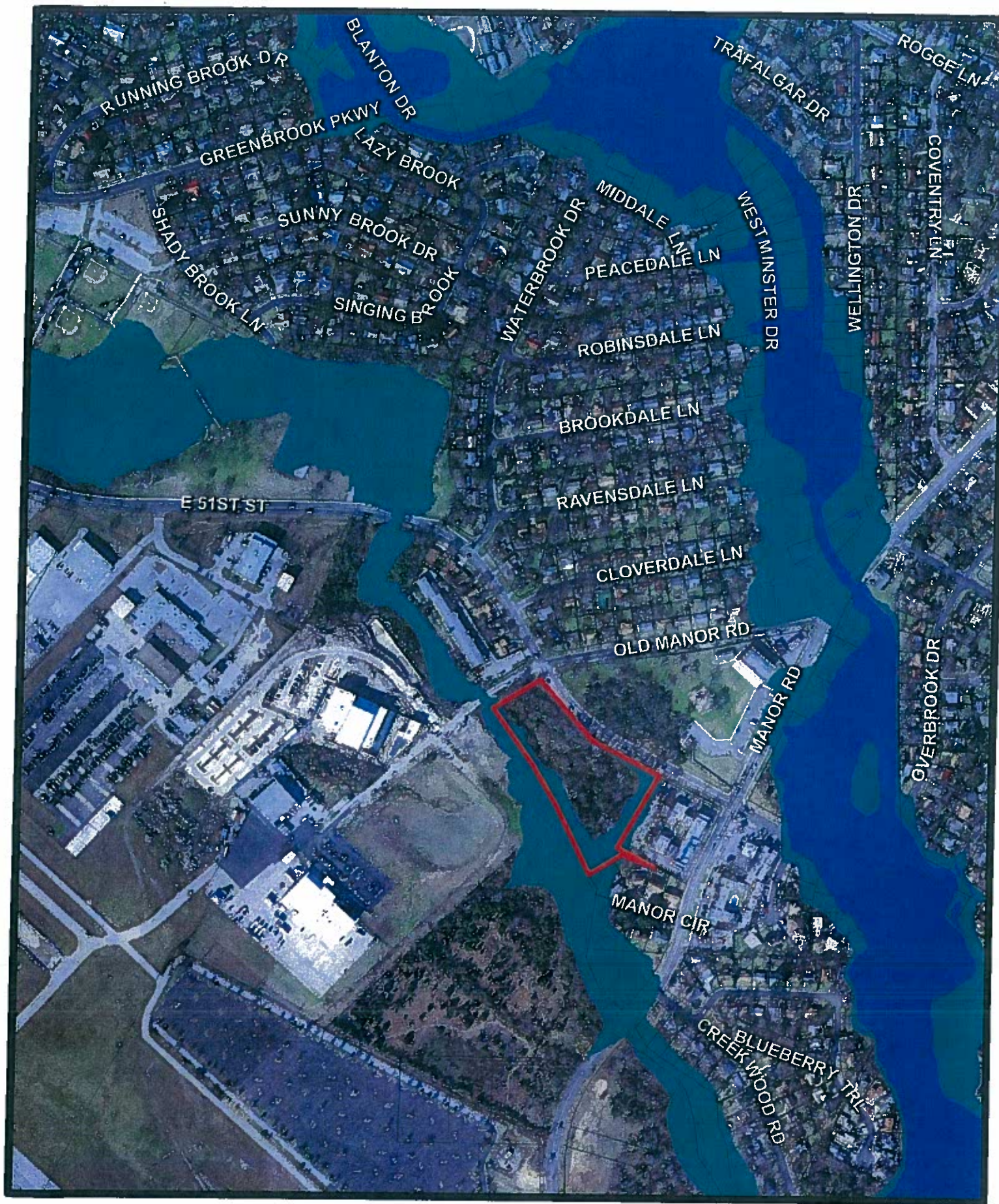

SUMMARY STAFF RECOMMENDATION

The staff recommendation is to grant the change from GR-NP (Community Commercial – Neighborhood Plan) district zoning to P-NP (Public – Neighborhood Plan) zoning district.

BASIS FOR LAND USE RECOMMENDATION (ZONING PRINCIPLES)

1. *The proposed zoning should be consistent with the purpose statement of the district sought.*

P- Public district is the designation for a governmental, civic, public service, or public institution use. A P zoning district designation may be applied to a use located on property used or reserved for a civic or public institutional purpose or for a major public facility, regardless of ownership of the land on which the use is located. The proposed Mueller Austin Energy substation is consistent with this purpose statement.

2. *Zoning should be consistent with the proposed Future Land Use Map (FLUM) or adopted neighborhood plan.*

The property lies within the University Hills/Windsor Park Combined Neighborhood Plan adopted on August 9, 2007. The current land use on the Future Land Use Map (FLUM) shows the subject property is designated as “Utilities” which is for land used or dedicated for public or private utilities including pipelines, utility lines, water and wastewater facilities, substation and telephone facilities consistent with the proposed zoning request and development.

EXISTING CONDITIONS

Site Characteristics

The site is currently undeveloped and heavily wooded. The property slopes from 51st Street toward the rear of the property where there is a floodplain.

Impervious Cover

The maximum impervious cover allowed by the P zoning district is established by a conditional use site plan. The maximum impervious cover allowed by the GR zoning district is 90%.

Environmental

The site is not located over the Edwards Aquifer Recharge Zone. The site is located in the Tannehill Branch Watershed of the Colorado River Basin, which is classified as an Urban Watershed by Chapter 25-8 of the City's Land Development Code. It is in the Desired Development Zone.

Impervious cover is not limited in this watershed class; therefore the zoning district impervious cover limits will apply.

This site is required to provide on-site structural water quality controls (or payment in lieu of) for all development and/or redevelopment when 5,000 s.f. cumulative is exceeded, and detention for the two-year storm. At this time, no information has been provided as to whether this property has any pre-existing approvals which would preempt current water quality or Code requirements.

According to flood plain maps, there is a flood plain within the project area.

Trees will likely be impacted with a proposed development associated with this rezoning case. Please be aware that an approved rezoning status does not eliminate a proposed development's requirements to meet the intent of the tree ordinances. If further explanation or specificity is needed, please contact the City Arborist at 974-1876. At this time, site specific information is unavailable regarding other vegetation, areas of steep slope, or other environmental features such as bluffs, springs, canyon rimrock, caves, sinkholes, and wetlands.

Standard landscaping and tree protection will be required in accordance with LDC 25-2 and 25-8 for all development and/or redevelopment.

Transportation

No additional right-of-way is needed at this time.

A traffic impact analysis was not required for this case because the traffic generated by the proposed zoning does not exceed the threshold of 2,000 vehicle trips per day. [LDC, 25-6-113]

Water and Wastewater

The landowner intends to serve the site with City of Austin water and wastewater utilities. The landowner, at his own expense, will be responsible for providing any water and wastewater utility improvements, offsite main extensions, utility relocations and or abandonments required. The water and wastewater utility plan must be reviewed and approved by the Austin Water Utility for compliance with City criteria. All water and wastewater construction must be inspected by the City of Austin. The landowner must pay the City inspection fee with the utility construction. The landowner must pay the tap and impact fee once the landowner makes an application for a City of Austin water and wastewater utility tap permit.

Site Plan Review

This site is over 1 acre. Any development of land on "P" public zoning over 1 acre requires a Conditional Use Permit. Once all site plan reviewers' comments are cleared, the site plan must then have a public hearing at Planning Commission, and can only be approved after Planning Commission approval.

Any development which occurs in an SF-6 or less restrictive zoning district which is located 540-feet or less from property in an SF-5 or more restrictive zoning district will be subject to compatibility development regulations.

Joi,

Attached is the layout for Mueller. There was a comment from the Planning Commission about allowing for commercial development or park-like features around the substation. We have constraints on the property that have made it difficult to position our equipment and still allow required electrical safety clearances and accessibility to the equipment. Here are some of the obstacles with the property that we have addressed:

1. Running parallel to 51st Street is Boggy Creek, which creates a Critical Water Quality Zone (CWQZ) and has flood plain implications. We have pushed the substation as close to the CWQZ as possible.
2. There is a 100-year flood plain that runs along Boggy Creek and through the eastern side of the property along 51st Street. The property to the east of the substation along 51st Street is quite steep and also borders the flood plain. We had to align the proposed sidewalk with the curb in this area to avoid the flood plain and building retaining walls.
3. Since we have to route a transmission circuit on either side of 51st Street, we must place a transmission structure between the curb and the substation wall to transition into one of the substation terminations.
4. We are installing a decorative screening wall around the substation. By setting the wall boundaries as far off the road as possible, we tried to provide visibility at the intersection of 51st and Old Manor Road for vehicular traffic. Between the wall and the road, we plan to install utility-compatible landscaping.
5. The property to the east of the substation that is undeveloped will have the underbrush cleared as much as City permitting allows, but will be maintained in its natural state for a vegetative filter strip.

Dear Planning Commissioners,

Tomorrow night, Austin Energy will be bringing a rezoning for 2403 E. 51st Street before you. The Windsor Park N'hood Plan FLUM shows this property as utility, and we discussed it at length during the planning process and believed that the "utility" was a flood plain. No one advised us otherwise. Reconsidering it again during the VMU process since E. 51st is a core-transit corridor (making the site inappropriate for an electric substation unless it's designed to be extremely pedestrian friendly!), we again wished to maintain the heavily treed site as green space. AE will cut down all the trees on the western end of the site.

I fault ROMA Design and AE for not coordinating a site *on* Mueller for the substation to service the redevelopment, but that's in the past and we must deal with the current reality. I also fault AE for not making earlier efforts to work with the community about this substation, but they did a much better job after both Windsor Park NA and the Windsor Park Contact Team objected to this rezoning. Both groups still have standing votes against that change from GR-NP to P-NP, which should be in the backup materials.

AE has gone as far as it can in pursuing an alternate site that is immediately adjacent to this proposed site, but is owned by the State of Texas and is leased to Robert Rodriguez's Troublemaker Studio. It is an unused portion of the property, and City staff/ROMA proposed a land-swap between the State and the City's CTECC (Emergency Call Center) that is quite brilliant (I've attached a drawing), but was rejected by State General Land Office and CTECC staffers.

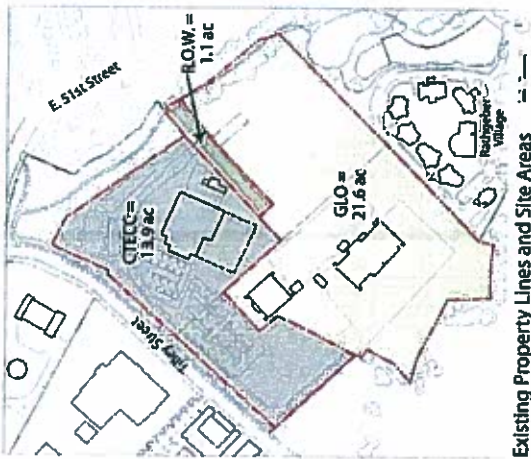
It is now a political issue, and both WPNA and the WPNPCT are pursuing the City Council and State elected officials to intervene. If the land swap isn't feasible, the Council could negotiate a site on Mueller with Catellus, as the economy has significantly slowed its redevelopment. Either way, Mueller should take more ownership of its utilities, and Windsor Park has been negatively impacted by the redevelopment more than any other adjacent neighborhood. ("Jug-handle" access, water tower, water lines tearing up streets for LONG periods, etc.) Drive the perimeter of Mueller and it's amazing to see public art, parks and green space on every edge but Windsor Park's.

I don't exactly know what the Planning Commission can do, but as I will not be present for your August 11th meeting since the Mueller Commission (for whom I am not speaking in this e-mail) meets that same night, I hope you can consider a delay or make some other ruling so that we can continue to pursue an alternative site. Since the proposed site is not on Mueller, it's out of the Mueller Commission's purview and we can do little to act on it.

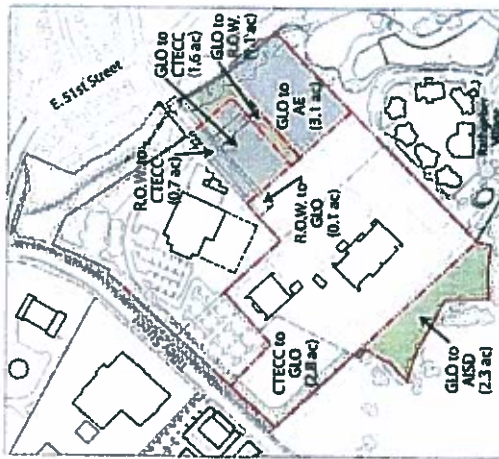

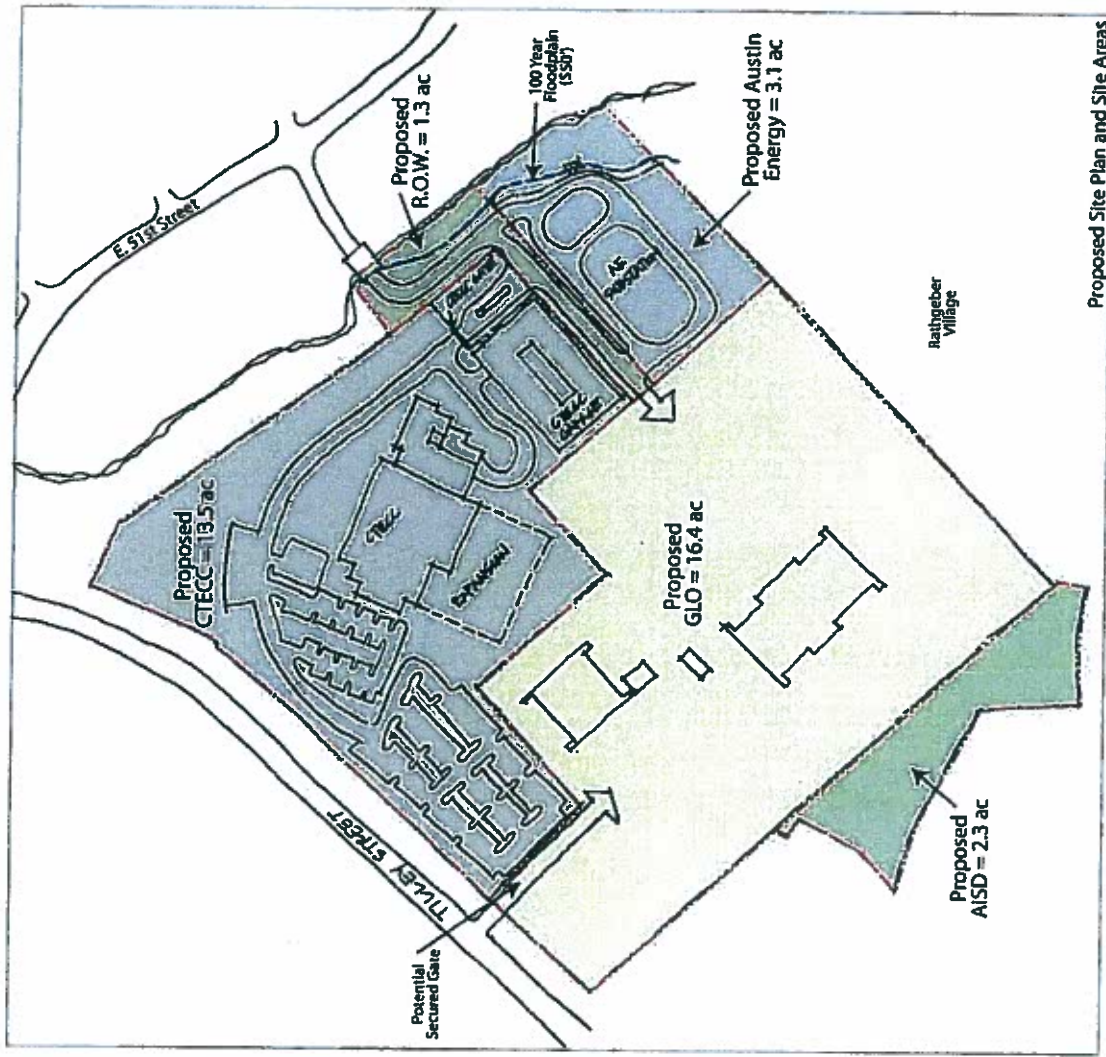


Existing Property Lines and Site Areas

All,

I've attached the March, 2009 letter approved by the Mueller Commission on the substation siting and rezoning request.

I want to echo Rick's overall comments and especially note that since March, AE did a great job of investigating an alternative site (thanks to Judy and Dorothy, probably more). The alternative appeared to be a win all around, but it was quietly killed. Lacking any public discussion of why it was unacceptable to some, we are at a loss to further discuss how to make it work and be a win for everyone. The Mueller Commission would welcome a public discussion of this alternative site or others that are more closely associated with Mueller than the 51st St. corridor site.

As stated in the letter, this is not directly a zoning issue, but more a siting issue.

I would like to add here that another avenue worth exploring by City Council is going with a gas-insulated substation (GIS) instead of the currently planned traditional, open air substation. The main advantage is that a GIS has a hard, secure footprint of about 1/2 acre or less, plus access, whereas a traditional substation is 1.5 to 2 acres hard footprint, plus access. This smaller footprint would surely expand our options for siting it on Mueller lands/off of 51st. The main disadvantage is that a GIS costs more than a traditional substation, perhaps up to 3 times more. I believe the City's best example of both the smaller footprint and cost is the Fiesta substation at 38 1/2 St. The GIS is much more in keeping with the overall Mueller design principles and I find it hard to believe we couldn't find a Mueller-specific way to finance the higher cost.

("Jug-handle" access, water tower, water lines tearing up streets for LONG periods, etc.) Drive the perimeter of Mueller and it's amazing to see public art, parks and green space on every edge but Windsor Park's.

I don't exactly know what the Planning Commission can do, but as I will not be present for your August 11th meeting since the Mueller Commission (for whom I am not speaking in this e-mail) meets that same night, I hope you can consider a delay or make some other ruling so that we can continue to pursue an alternative site. Since the proposed site is not on Mueller, it's out of the Mueller Commission's purview and we can do little to act on it.

Thanks, and I'll be happy to answer any questions.

RE: Mueller Austin Energy Substation

Mayor and Council Members, Planning Commission members,

Since the earliest plans for the redevelopment of Mueller, we have all known the redevelopment would require a new substation be built in the area. In the late 1990's the site for this substation was roughly settled to be adjacent to the Central Texas Emergency Command Center, well within the Mueller site boundaries. This siting was ideal in adherence to one of the guiding principles of the Mueller Masterplan – Compatibility with Surrounding Neighborhoods. Because of this Masterplan principle, and because the substation is only being built because Mueller is being built, the Mueller Commission feels compelled to weigh in on the siting of the substation.

Sometime around 2000, the CTECC site became unfeasible for compatibility reasons – both real and perceived – with the substation and its transmission lines. Alternative sites were reviewed, eventually resulting in the current site being proposed for rezoning to allow a substation. But public communications broke down as these compatibility issues began to surface. Looking back, the Mueller Commission regrets both that we were not engaged by Austin Energy and the City at this time, and equally that we did not proactively seek updates on the substation from Austin Energy. No one was actively hiding information, there was simply a breakdown in communications all around.

However, several principles remain to be addressed. While no one wants a substation or transmission lines near them, the Mueller substation is necessitated by Mueller and should not be forced into an adjacent neighborhood; ideally it should be on the Mueller site.

The Mueller Commission fully realizes a lot of work and money has gone into the current site, however, **the Mueller Commission recommends that Austin Energy re-look at alternative sites, with the Mueller Commission and other stakeholders, in a timely fashion, that do not impact adjacent neighborhoods (in this case, Windsor Park) as much as does the current site.** While this recommendation is neutral to the rezoning request, we feel the site location is the core issue.

As we emphasized during the reclaimed water tower discussions, and now must emphasize again, as our major utilities – electric, cooling, water, wastewater, etc. – continue to build to meet demand in the urban core, then the City must provide each utility greater guidance and resources for community process, design and construction.

We will retain this issue on our monthly agenda and seek additional opportunities to weigh in as appropriate or as requested. We invite you to contact your appointees on the Mueller PIAC with any specific concerns, hopes or expectations.

Please reject Austin Energy's rezoning request for the proposed Mueller electric substation at 2403 E. 51st Street. (Case C14-2008-0242).

On the face of it, the zoning change from GR-NP to P-NP may seem reasonable. However, it is the Windsor Park neighborhood's only protection from the construction of an electrical substation destined to serve primarily the Mueller Development, not our neighborhood. It is one of several projects, such as the reclaimed water tower, that impact the quality of our neighborhood environment to better serve other areas near and far. The substation is in direct conflict with our neighborhood plan and with the designation of East 51st Street as a Core Transit Corridor. Its construction will serve as an additional barrier between Windsor Park and the Mueller Development. I would prefer to see a concerted effort to mitigate the current and potential barriers between our neighborhoods.

As a member of both the Windsor Park Neighborhood Association and the Windsor Park Neighborhood Plan Contact Team, I have participated in meetings concerning the zoning, have met with representatives of Austin Energy, and am aware of attempts to arrange a land swap that would have resulted in a more equitable conclusion for our neighborhood. Please encourage the concerned parties to continue negotiations by not recommending the proposed zoning change.

I will not be present at tomorrow night's Planning Commission meeting when the rezoning case for 2403 Manor Road (Austin Energy Mueller Substation) returns, as the RMMA Plan Implementation Advisory Commission meets at the same time.

I wanted to let you know that meetings and negotiations continue between the City of Austin and the State of Texas on a land trade that would provide a preferable location for the proposed electric substation. Sonny Poole of Austin Energy, Leo Lopez of Catellus, Jim Adams of ROMA Design Group, Barbara Rush from Council Member Morrison's office and I attended a meeting of the Board of the Combined Transportation and Emergency Communications Center (CTECC) this past Wednesday. The Board had little previous knowledge of this case, but did not have any major objections to the land trade that would affect their site, or at least I came away from the meeting with that impression.

Austin Energy also has provided specifications and test results on similar substations to a consultant for Troublemaker Studios, the State's tenant, for a report on possible interference from a substation that would be about 500 feet closer to the studios if the land trade were to occur. The report was provided to the Mayor's office last week. I would ask that you request that information, find someone with the technical ability to interpret its findings, and possibly advise the City Council to request an independent study to confirm those findings.

I know that the rezoning has been postponed three times already, but I am in hopes that the Commission might allow at least one more delay so that negotiations between the City and State can continue.

I want to express my gratitude for your understanding of the issues surrounding this rezoning, and sincerely thank you for your patience with this case.

To All:

Attached is the report and letter provided by Troublemaker Studios. Unfortunately the report does not meet the expectations AE had for a comprehensive analysis of the issue. There is no substance to the report it is more speculation and assumption. There are also mis-statements concerning AE's role in the process. Claims were made that data was not provided, however, the emails I have show we provided a great deal of information and on every occasion asked if additional data was needed.

From the way Troublemaker Studios has handled the report process and the manner in which the report was provided, it would appear that there will be no way to appease their concerns and they are relying on empathy from the Mayor and council to have them support their position.

Yesterday, I picked up the report and then had to provide another presentation to CTECC. I was very surprised by the CTECC Board when they told me they had not been aware of the substation issue prior to this week.

The Board member representing Travis County was the most vocal and spoke of possible cooperation in allowing AE to put the substation on the site. However, he also spoke of the Board's responsibility to their citizens to look out for the quality of their service and the possible need to expand their facilities onto that site. He stated an interest in not having this issue decided by the City Council.

I assured them that AE would be interesting in working with the CTECC Board on options that would allow AE to use the alternate site. I also made it clear that AE would need something in writing from the Board outlining what they would commit to doing, otherwise, this was just more discussion that was not moving the issue forward. They said they would discuss it after we left and I will follow up with Terry Carroll on their decision

That said, it seems that this will eventually end up as a political issue. I am asking for a meeting of AE staff to identify how to proceed. I am scheduled to go before the

Planning Commission on Tuesday, October 13th to once again ask for a change in zoning to the site on 51st. It is my estimate that we will be postponed again because no resolution was reached. I am planning to again ask that the zoning be approved as we work on alternate site issues. I think it important that AE have a unified response to the Troublemaker letter and report and a strategy for proceeding with the zoning and the eventual locating of the site.

After a recent meeting with you by Mr. Santiago Martinez of Troublemaker Studios regarding the above-referenced matter, you asked that Mr. Martinez research potential problems that the proposed electrical substation would cause if it were located on land adjacent to Troublemaker Studios (the "Studios") which is owned by the State of Texas. Enclosed is a report which was commissioned by the Studios at your request in order to document the problems and potential problems the electrical substation would cause. As you can see, we cannot tell you exactly the problems the electrical substation would cause since we do not know the specifics of the equipment to be located at the substation site. We also do not have any reports from the City of Austin regarding the specifics of the substation site. However, we can tell you that any increase in ambient sound, vibration, lights or electromagnetic fields could be devastating to the continued operation of the Studios.

Additionally, we oppose locating the substation site on the State of Texas property adjacent to the Studios because of the very real risks associated with interference from the substation site with equipment located in the Studios. The enclosed report identifies those problems and potential problems. Furthermore, if a problem were to occur, whether it is based on current equipment or equipment which has yet to be developed or has yet to be used at the Studios, the cost of such problem would be astronomical and would be a real burden for the Studios. The Studios' insurance company would not cover that loss or, at the very least, could dispute that loss. Since making these movies involves tens of millions of dollars, we would not think the City of Austin would be willing to guarantee absolutely no interference, which is what we would require in order to guarantee that we remain solvent. We agree with the neighborhood that this substation should be placed on the Catellus property for which it serves but we cannot agree with locating it on the property adjacent to the Studios as requested. We regret this inconvenience to the City of Austin but it is absolutely critical for the Studios' survival to take this position.

POTENTIAL IMPACT FROM AUSTIN ENERGY PROPOSED "MUELLER SUBSTATION" LOCATED ADJACENT TO TROUBLEMAKER STUDIOS

September 2009

OVERVIEW AND FOCUS OF THIS REPORT:

> Austin Energy proposes to locate a new electrical substation within close proximity to Troublemaker Studios. Airborne sound, structure and ground borne sound and vibration, as well as Electro-magnetic energy and light pollution could adversely affect the filmmaking operations that routinely take place inside and outside at the Studios. This report will focus primarily on sound and vibration issues.

According to documents provided by Austin Energy, substation buildings and transformers could be located within 50' of the Troublemaker parking lot, where outside filming takes place, and within 200' of the actual filming stages and technical facilities, where filming and extensive post production takes place. A fence or wall is shown around the AE facilities, but no details on the extent design or construction of any fence or wall have been provided.

Austin Energy has not provided any data on types, manufacturers, or models of electrical equipment that might locate within the substation. Therefore no analysis of the real impact on Troublemaker's facilities can be made. However, extensive case histories show that some sound and vibration, as well as possible instances of RF pollution, can be expected to emanate from typical substations.

The microphones used to capture "production sound" on a live film set typically have extremely high sensitivities, wide dynamic range and extend below and above the threshold of human hearing in their response.

Additionally, during filming there is extensive use of radio transmitters and wireless microphones, transmitting in both the UHF and VHF bandwidths.

One of the most ubiquitous microphones used is a Sennheiser MKH 416. Its published sensitivity rating enables the mic to pick up sounds as quiet as a whisper from 50' away.

While typically sited "sound pressure level" readings are useful for establishing broad and base levels of sound in any given area, these measurements are not particularly useful or "real world." Austin Energy has provided current readings in dB(A) taken near Troublemaker Studios, but these were

measured early-midmorning, and not the usual time when filming would take place. Moreover, the "dB(A)" measurement is almost completely "frequency blind" and does not reflect low frequency "hum" or the predominate audible sound energy that would most likely be produced by electrical equipment and picked up by microphones.

"Transformer hum", while a generic and non-technical term, nonetheless is audible and measurable in many case histories we have researched. This "hum" originates as a 120hz primary with octave overtones.

Noise from increased truck traffic in and out of the substation facilities can be expected.

During construction of the substation facilities, and in the event of any renovations or expansion, intolerable levels of construction noise would be typical.

Cooling fans, which might be included in the substation equipment or operation, can generate high noise levels.

The EMF potential problems are even greater. As documented by Austin Energy, any number of sources for RF "noise" could be found at the substation facilities and adversely effect the digital and transmission equipment used in filming and postproduction. We contacted several major manufacturers of film equipment, as well as consulting engineers, and of greatest concern for EMF interference are Cameras, Lights (film lighting), and storage media. A single bad ground connection or poor solder joint on a switch or connector can absolutely cause destructive EMF interference to any electronic equipment in the vicinity.

> We have examined dozens of case histories that discuss, examine or review various instances of utility substations built within proximity of residences, and businesses of all types. While the equipment and activities of a substation generally do not cause unhealthy or substantially disrupt most businesses, the proximity of the proposed Mueller substation to Troublemaker Studios give more than reasonable cause for concern. Troublemaker is a unique business in Austin, shooting and providing postproduction for major films. Their track record, their contribution to the local and State economy cannot be over emphasized. Their studios and facilities operate more sensitive digital, RF-based, and filming equipment in one place than any other company in the State. After analyzing technical data, case histories, and all submittals from Austin Energy and other sources, it is definite that there is **potential** for interference from sound, vibration, EMF and light pollution from an electrica substation located nearby.

> As in the case of most utilities contemplating the location of an electrical substation in close proximity to homes and businesses, Austin Energy should create and provide a thorough mitigation plan for this proposed facility. Case histories show that it is incumbent on the utility to provide this planning, and submit alternatives and options until the community is satisfied.

Mitigation typically includes planning for a substantial wall that would block sound and light. The design of such a wall would be based on the calculated sound production from all sources inside the facility, and result in a zero increase in sound and vibration outside the facility, even at close distances. This would include increased vehicle traffic as well as equipment. Attention to the selector of equipment, its mounting and installation, as well as analyzing its "operational" modes is required.

Plans for grounding and shielding should have the same basis and goals, with a guarantee to the community that EMF levels would always be controlled and monitored, and cause zero interference any equipment used in nearby businesses or facilities.

Austin Energy has asked for "specific" data about equipment used at Troublemaker Studios. Manufacturers of the type of equipment used at Troublemaker do not publish data on interference thresholds. There are literally thousands of individual pieces of sensitive equipment in use, and as well in the nearby CTECC facility, which could be affected by sound, vibration, light pollution or EMF emissions.

Examining case histories around the country and the world, the mitigation design approach is not typically a "survey" of the potential interference thresholds of every piece of gear; rather the equipment and facilities proposed within the substation are examined and that data brought into the design of such mitigation to produce a "net zero" increase in localized emission of all types.

The approach to sound and vibration control is to analyze the source and provide remedies that are appropriate. The closer to the "source", the more efficient the mitigation will be. Since Austin Energy has not to date provided any information about equipment or design of the facility, or mitigation planning, it is impossible for this Consultant to make any calculations on efficiency of mitigation elements.

Austin Energy received and reviewed the letter sent to you by Troublemaker Studios regarding the possibility of locating our proposed Mueller substation adjacent to their property. As their response indicates that any level of EMF, noise, light or vibration would cause them potential operating problems; we plan to return to the Planning Commission on October 13, to request the rezoning of the property we own on 51st Street.

Based on the development plans in the area we project that we could experience a capacity deficit in 2011 without a new substation in the area. Given that projection we need to have the new substation in service by May 2011 to provide reliable service and power quality for the summer. In order to meet this deadline we need to begin our permitting process by mid November 2009.

We are truly indifferent to which site we ultimately build on and we will continue to work with both Troublemaker Studios and CTECC to see if their concerns can be mitigated as we move toward our November deadline.

I will not be present at tomorrow night's Planning Commission meeting when the rezoning case for 2403 Manor Road (Austin Energy Mueller Substation) returns, as the RMMA Plan Implementation Advisory Commission meets at the same time.

I wanted to let you know that meetings and negotiations continue between the City of Austin and the State of Texas on a land trade that would provide a preferable location for the proposed electric substation. Sonny Poole of Austin Energy, Leo Lopez of Catellus, Jim Adams of ROMA Design Group, Barbara Rush from Council Member Morrison's office and I attended a meeting of the Board of the Combined Transportation and Emergency Communications Center (CTECC) this past Wednesday. The Board had little previous knowledge of this case, but did not have any major objections to the land trade that would affect their site, or at least I came away from the meeting with that impression.

Austin Energy also has provided specifications and test results on similar substations to a consultant for Troublemaker Studios, the State's tenant, for a report on possible interference from a substation that would be about 500 feet closer to the studios if the land trade were to occur. The report was provided to the Mayor's office last week. I would ask that you request that information, find someone with the technical ability to interpret its findings, and possibly advise the City Council to request an independent study to confirm those findings.

I know that the rezoning has been postponed three times already, but I am in hopes that the Commission might allow at least one more delay so that negotiations between the City and State can continue.

I want to express my gratitude for your understanding of the issues surrounding this rezoning, and sincerely thank you for your patience with this case.

Respected Members of the City of Austin Planning Commission:

My name is Athar Tayyab. I have been a resident of City of Austin since 2001. I work as a senior managing consultant at IBM, and live in NW Austin with my wife and three children.

I am here to represent the Austin Muslim community in general and the Islamic Center of Greater Austin (ICGA) in particular. I am currently serving as the chair of the ICGA Board of Trustees.

Background: Austin, the capital of the State of Texas, is the second high-tech city in the United States. Recently, it was rated the best city in the United States to live in, because of its fast growing economy and clean environment. It is also the home of University of Texas. In this fast growing city, the Muslim population has grown manifold in the past years with a current estimate of over ten thousand. The Muslim population is largely made up of tech sector employees, business owners, students, and many other professionals.

Establishment: The Islamic Center of Greater Austin (ICGA) was established in March 1977 as a non-profit religious organization registered with the State of Texas and is affiliated with the Islamic Society of North America (ISNA) and the North American Islamic Trust (NAIT), which is a subsidiary of ISNA, as its trustee. ICGA property is WAQF under NAIT. ICGA is governed by a constitution and its by-laws. The structure of ICGA consists of an administrative body called Board of Trustees (BT). All members of these boards are elected per the constitution.

Organization History: ICGA has been in operation since March 1977. The mosque started in a 2000 sqft building without any parking space, located at Nueces St in downtown Austin. It was expanded in 1982 with the purchase of an adjacent building that was remodeled into a prayer hall. From 1982 till 1999, the Muslim community was barely able to manage its activities in those two buildings. Alhamdulillah, by the mercy of Allah SWT and the generous support of the local and outside communities, in November 1999, ICGA completed a two story building which houses a mosque to accommodate around 1000 brothers and sisters and a full time Islamic school on the second floor, located at 5110 Manor Rd.

ICGA Activities: During this course of time (1997-2009), ICGA established daily prayers, a weekend Islamic school, a full time licensed Islamic school (in 1997), a dawah center for Muslims and non Muslims and prison inmates, audio and video library with countless Arabic and English literature, social activities including Eid prayers, picnics, halaqas by the Sheik, weekly quranic school, seminars, workshops and symposiums, Islamic Counseling Center for battered families, marriage contracts, and ghusul facility and burial services. Also, ICGA maintains a 25-acre Muslim cemetery.

ICGA serves the entire Austin Muslim community, estimated to be over 10,000. Our active membership

exceeds 2000. On a weekly basis, over 500 people attend our services and programs.

Full-time Islamic School: Austin Peace Academy has classes from Pre-K through eleventh grade, for ages 3 years and up, with a current enrollment of over 180 students. The school employs several full time teachers, including Islamic studies and Arabic, a principal, and two secretaries. The school is licensed by the Texas Protective and Regulatory Services (PRS) and offers curriculum that meets guidelines of Texas Education Agency. APA is also accredited by SACS-CASI, the largest accreditation agency in the world.

Here is the summary of our issues and concerns:

- Austin Muslim community purchased 7 acres Waqf property at Manor & 51st street to build Islamic Center, Masjid, and school. Waqf is an Islamic term and for Muslims, it is considered a trust that can never be used for any other purpose other than worship and service
- ICGA was later forced to sell portion of the property to City of Austin under the threat of "land condemnation," against our will and under the threat of forceful seizure
- The property in question is at the corner of Old Manor Rd and 51st Street. City of Austin told us that this land would remain as drainage easement and would not be used for any power station or any other major utility structure
- The city is now considering a re-zoning request from Austin Energy to build a power sub-station to support the Mueller development project

ICGA opposes this on the following grounds and concerns

- The redeveloped Mueller site should accommodate need for Mueller power substation, and not use this land that was grabbed from ICGA and was intended for drainage easement
- It appears that it is not OK to impede on the Mueller development area for very unsightly infrastructure to support that areas energy needs, but it appears OK to do the same to an adjacent possibly "lessor considered" neighborhood and school area. Why?
- ICGA is very concerned about the safety and health hazards posed by the proposed substation
- We are particularly concern about the potential health effects of the electric and magnetic fields (EMF) emanating from such substations, whether such concerns are real or perceived. These concerns have adverse effect on ICGA's interests.
- We are concerned about the negative impact to the property value of ICGA and surrounding neighborhood
- The proposed structure design of the substation will also have a negative impact on the appearance and aesthetic appeal of the neighborhood

I am not sure why Austin Peace Academy is not being cited as a school in the substation vicinity in the maps submitted as part of the re-zoning request? Also, as properties are directly across Manor Rd from the proposed substation location, ICGA and APA are not noted as key stakeholders / organizations in the same request. Why?

Please note that initial forceful sale of ICGA property to City of Austin had a significant impact on ICGA future plans. When we purchased the land, we had envisioned to fully develop the main property (5110 Manor Rd) with a sprawling campus supporting all our needs and use the smaller parcel at 2403 E. 51st Street, to help us meet the impervious cover requirements of the city zoning regulations. Our members feel very strongly about the initial land acquisition and are now outraged that city would considered such an action to further damage ICGA interests and needs.

I have something very personal at stake here also. My daughter, Faiza, has been a student at Austin Peace Academy since 2001. I am very concerned for her safety and well being. The substation will be so close to the school which has approximately 180 students (Pre-K to 11th Grade). I am particularly concerned about potential health effects of the electric and magnetic field emanating from such substations. NIEHS (National Institutes of Environmental Health Sciences) evaluation concludes that there is a fairly consistent pattern that links EMF exposures with increased risk of leukemia in children.

My phone has been ringing off the hook all day with calls from parents and community members with similar concerns. This will also send a chilling message to all our potential new parents who will now think twice about sending their children to Austin Peace Academy. Why does City of Austin want to place ICGA and APA in such a position?

To be succinct, placing a power station directly across the street from a school is hard to fathom. The children of the school start there at age three. The health and safety risks to young children from power plants ranges from "uncertain" to terribly dangerous. Please locate this infrastructure in the Mueller Development area, where it belongs. Thank you for your consideration.
