

M/WBE Summary

Participation sub-goals stated in the solicitation were 1.90% African American, 9.00% Hispanic, 4.90% Native/Asian; 15.80% WBE. The recommended firms provided MBE/WBE Compliance Plans that met the goals of the solicitation was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 597 firms on July 10, 2009. The RFQ was obtained by 77 firms, and 16 firms submitted qualification statements. Two of the firms were certified MBE/WBE firms. The evaluation of the submittals of the 16 firms resulted in the following recommendation:
