

M/WBE Summary

Participation sub-goals stated in the solicitation for design phase services were 1.90% African American; 9.00% Hispanic; 4.90% Native/Asian and 15.80% WBE. The recommended and alternate firms provided an MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.

Separate MBE/WBE participation goals will be established for the construction packages associated with this project, and the Design-Builder's compliance plan for such services will be approved prior to staff returning to Council with recommended contract amendments.
