

**ORDINANCE NO. 20091105-038**

**AN ORDINANCE APPOINTING THE PRESIDING JUDGE, ASSOCIATE JUDGES INCLUDING THE DOWNTOWN AUSTIN COMMUNITY COURT JUDGE, AND SUBSTITUTE JUDGES OF THE CITY OF AUSTIN MUNICIPAL COURT; AND ESTABLISHING COMPENSATION AND BENEFITS.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The City Council appoints Evelyn McKee as the Presiding Judge of the Municipal Court for the term beginning January 1, 2010, and ending December 31, 2013.

**PART 2.** The City Council appoints the following individuals as Associate Judges of the Municipal Court for the term beginning January 1, 2010, and ending December 31, 2013:

**PART 3.** The City Council appoints Associate Judge Michael Coffey to serve as the judge of the Downtown Austin Community Court.

**PART 4.** The City Council appoints the following people as Substitute Judges for the Municipal Court for the term beginning January 1, 2010, and ending December 31, 2013:

**PART 5.** The City Council does not appoint to the Municipal Court the term beginning January 1, 2010, and ending December 31, 2013, any person not specifically named in this ordinance.

**PART 6.** Compensation for the Presiding Judge is \$4361.60 per pay period; annualized to \$113,401.60, paid in accord with normal payroll practices.

**PART 7.** Compensation for an Associate Judge, including the Downtown Austin Community Court Judge, is \$3901.60 per pay period; annualized to \$101,441.60, paid in accord with normal payroll practices.

**PART 8.** Compensation for a Substitute Judge is \$39.47 per hour.

**PART 9.** The Presiding Judge and Associate Judges, including the Downtown Austin Community Court Judge, shall receive the following benefits:

- (A) Participation in the Employees' Retirement System on terms applicable to full time, exempt City employees.
- (B) Participation in those group benefits plans and programs set forth in Chapter A, Section III.B. of the City of Austin Personnel Policies under the terms and conditions applicable to full time (40 hours per week) exempt employees of the City;
- (C) Accrual of 1.92 days of paid vacation leave per month (23 days per year) with a maximum accumulation of 400 hours;
- (D) If eligible, service incentive pay in the same amount and under the same conditions as non-Civil Service employees.

**PART 10.** A substitute judge shall serve only as scheduled by the presiding judge, and is not eligible for City benefits or compensation except as provided for in Part 8 of this ordinance. Part 9 of this ordinance does not apply to a substitute judge.


**PART 11.** The terms "sick leave," "vacation," and "holidays" have the same meaning given to those terms in the City of Austin Personnel Policies for Non-Civil Service Employees.

**PART 12.** This ordinance takes effect on January 1, 2010.


