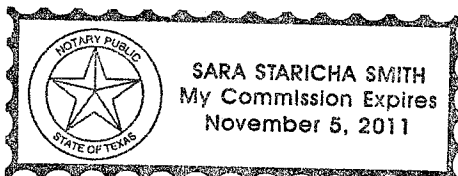

**NOTICE OF PUBLIC HEARING**  
NOTICE IS HEREBY GIVEN that the Wallis Cultural Education Facilities Finance Corporation (the "Corporation"), a non-profit corporation created by the City of Wallis, Texas pursuant to Article 1528m, Vernon's Texas Civil Statutes, will hold a public hearing on November 4, 2009, commencing at 10:00 a.m., Colorado Room, 17th floor, Andrews Kurth LLP, 111 Congress Avenue, Suite 1700, Austin, Texas 78701, to provide an opportunity for all interested persons to be heard with respect to a proposed loan from Compass Bank (the "Bank") to the Corporation in the maximum amount of \$7,500,000 and a proposed loan from the Corporation to Young Mens Christian Association of Austin (the "Borrower") in the same amount, collectively, the "Loans", all pursuant to a Loan Agreement by and among the Corporation, the Bank and the Borrower. The Loans are being made for the purpose of: (A) financing the improvement, expansion and renovation of, an approximately 64,000 square foot YMCA facility, containing gymnasium, pool and fitness facilities, located at 1100 W. Cesar Chavez, Austin, Texas 78703; and (B) an approximately 30,000 square foot YMCA facility, containing gymnasium, pool and fitness facilities, located at 6219 Oaklaire Dr., Austin, Texas 78735; and (C) paying certain expenses in connection with the Loans (collectively, the "Project"). The Project is owned by the Borrower. The Loans are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower. All interested persons are invited to attend the hearing to express their views, both orally and in writing, with respect to the Loans and the Project.
