## **ORDINANCE NO.**

AN ORDINANCE WAIVING THE REQUIREMENTS OF SECTIONS 14-1-32 AND 14-1-33 OF THE CODE REGARDING THE NAMING OF A FACILITY AND NAMING THE HEALTH AND HUMAN SERVICES LEVANDER LOOP CAMPUS LOCATED AT 7201 LEVANDER LOOP, AUSTIN, TEXAS, THE BETTY DUNKERLEY CAMPUS.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

## **PART 1.** Findings.

- (A) Mayor Pro Tem Betty Dunkerley is a long time Central Texas community leader, and left her mark on a variety of initiatives which are part of her legacy providing credible service to the Austin community and the City of Austin from March 1990 through June 2008.
- (B) Mayor Pro Tem Dunkerley was the Chief Financial Officer, Assistant City Manager, Council Member and Mayor Pro Tem for the City of Austin during the period March 1990 through June 2008.
- (C) Mayor Pro Tem Dunkerley was responsible for the City's financial services, including Budgeting, Controller's Office, Fleet Services, Building Services, Purchasing, Regulatory Affairs, Treasury, the Utility Customer Service Office and Office of Minority and Business Affairs.
- (D) Mayor Pro Tem Dunkerley oversaw the Health and Human Services Department, Primary Care, Parks and Recreation Department, and Neighborhood Housing and Community Development Department.
- (E) Mayor Pro Tem Dunkerley was involved in major decisions the City of Austin made. For example, the Brackenridge lease, securing a long term water supply, the acquisition of land for the preservation of green space and a new animal shelter.
- (F) Mayor Pro Tem Dunkerley was instrumental in orchestrating the Minority Business Enterprise/Women Business Enterprise Ordinance, which has given our small businesses opportunities to receive contracts with the City of Austin.
- (G) Mayor Pro Tem Betty Dunkerley was instrumental in the formation of the Travis County Health Care District.
