

**ORDINANCE NO.**

**AN ORDINANCE WAIVING THE REQUIREMENT FOR A TEMPORARY FOOD PERMIT; WAIVING CERTAIN FEES AND COSTS; AND WAIVING THE REQUIREMENT FOR A LICENSE AGREEMENT FOR THE 2010 AUSTIN FARMER'S MARKETS, A CITY CO-SPONSORED EVENT, DURING THE 2010 CALENDAR YEAR.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** Council waives the requirement of Chapter 10-3 (*Food and Food Handlers*) of the City Code for a temporary food permit for registered participants in the 2010 Austin Farmer's Markets, a City co-sponsored event with the Sustainable Food Center. The markets will be held at Republic Square Park and at the intersection of Triangle Avenue and 46<sup>th</sup> Street (bordering Triangle Park) on selected Saturdays during the 2010 calendar year. Food vendors for the 2010 Austin Farmer's Markets shall follow the City's temporary food service guidelines and the requirements of City Code Chapter 8-3 regarding food, beverages and containers.

During 2010, the Farmer's Market may also conduct weekday daytime activities in Republic Square Park as part of a one year pilot program. The pilot program will be defined in a contract with the Sustainable Food Center.

**PART 2.** Council waives the following fees and charges for the 2010 Austin Farmer's Markets. Fees that have been paid shall be reimbursed to the Sustainable Food Center.

**PART 3.** Council waives the requirement of Chapter 14-11 (*Use of Right-of-Way*) of the City Code for a license agreement to use public property for the 2010 Austin Farmer's Markets.

**PART 4.** Vendors at the 2010 Austin Farmer’s Market at Republic Square Park will be allowed to relocate to the 400 block of West 4th Street when park restoration work begins related to construction of the federal courthouse. The temporary layout will be approved by City staff.
