Bid documents were distributed to 4 general contractors. Bids were opened on March 4, 2010. Asphalt Paving Company of Austin, Inc. submitted the lowest of three bids received:

67.86% Non M/WBE prime participation; 1.73 % African American; 6.83% Hispanic; 0.10% Native/Asian; 8.65% WBE; and 14.83% Non M/WBE subcontractor participation.
