

M/WBE Summary

Participation subgoals stated in the solicitation were **1.9%** African American; **9.0%** Hispanic; **4.9%** Asian/Native; and **15.9%** WBE. The recommended firms provided MBE/WBE Compliance Plans that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department. The alternate firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to two hundred and three (203) firms on January 15, 2010. The RFQ was obtained by thirty-nine (39) firms, and nine (9) firms submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the nine (9) firms evaluated, five (5) firms were short-listed and interviewed. Interviewing of the short-listed firms results in the following recommendation.
