

**M/WBE Summary**

Bid documents were distributed to 16 general contractors. Bids were opened on April 8, 2010. The contract price includes a \$50,000 allowance for dispute resolution services and a \$1,500 allowance for surface re-vegetation. S. J. Louis Construction of Texas Ltd. submitted the lowest of 8 bids received:
