

### **M/WBE Summary**

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 139 firms on January 15, 2010. The RFQ was obtained by 63 firms, and ten firms submitted qualification statements. None of the firms were certified MBE/WBE firms. Of the firms evaluated, two firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following ranking:

TOP RANKED FIRM: CHASCO CONSTRUCTORS, LTD. L.L.P.  
SECOND RANKED FIRM: HARVEY-CLEARY BUILDERS

Participation subgoals stated in the solicitation for design phase services were **1.90%** African American; **9.00%** Hispanic; **4.9%** Native/Asian and **15.80%** WBE. The top-ranked firm and second-ranked firm provided an MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department.

Separate MBE/WBE participation goals will be established for the work packages for construction associated with this project, and the Design-Builder's compliance plan for such services will be approved prior to staff returning to Council with recommended contract amendments.
