

## **M/WBE Summary**

Participation Goals for this solicitation were specifically for Preconstruction Phase Services (including General Conditions) and they are **4.56%** MBE and **2.36%** WBE. Both the Top ranked firm and the Second ranked firm submitted a MBE/WBE Compliance Plan that met the goals of the solicitation and were approved by the Small and Minority Business Resources Department. Separate MBE/WBE participation goals will be established for the construction packages associated with this project, and the Construction Manager's compliance plan for such services will be approved prior to staff returning to Council with recommended contract amendments.

The RFQ was obtained by forty-six firms, and twelve firms submitted qualification statements. None of the twelve were certified MBE/WBE firms. Of the twelve firms evaluated, three firms were short-listed for Phase II, Request for Proposal. Proposals were evaluated and interviews conducted with the short-listed firms. Interviews resulted in the following ranking:
