#### 6. PROPOSED AMENDMENTS TO CITY CODE 9-4-14 (SIT/LIE ORDINANCE)

Bill Brice, Downtown Austin Alliance, briefed the Commission on proposed amendments to City code 9-4-14, known as the "Sit / Lie Ordinance". There was a motion by Commission Member Haas, seconded by Commission Member Schorre, that the Downtown Commission opposes the proposed amendments to the Sit/Lie Ordinance.

A substitute motion that the Downtown Commission supports the existing City Code 9-4-14 and feels it is a fair and effective tool in promoting a clean, safe and inviting environment for

residents, employees and visitors, and believe any additional exemptions will diminish its intent and effectiveness, was approved on Commission Member Sher's motion, Commission Member Haas' second, on a 13-0 vote.

The commission discussed but took action on the formation of committees.

Staff Liaison Michael Knox informed the downtown Commission that Texas Facilities Commission staff would be willing to host a group to present the status of Capitol Complex planning.
