

## M/WBE Summary

Bid documents were distributed to 17 general contractors. Bids were opened on July 8, 2010. Pepper-Lawson Construction, L.P. submitted the lowest of 8 bids received:

The contractor's choice of work methodology provides for 18 areas of subcontracting opportunities which are listed below.
