**BYLAWS OF THE
BOARD OF ADJUSTMENT
AND
SIGN REVIEW BOARD**

ARTICLE 1. NAME.

The name of the board is the Board of Adjustment. Under Section 2-1-181 (*Sign Review Board*) of the City Code, the members of the Board of Adjustment and two additional persons appointed by council are the Sign Review Board.

ARTICLE 2. PURPOSE AND DUTIES.

(A) The purpose of the Board of Adjustment is to:

- (1) hear and decide a request for a variance from the requirements of Chapter 25-2 (*Zoning*), except as otherwise provided by the Code;
- (2) hear and decide an appeal of an administrative action under Chapter 25-2 (*Zoning*);
- (3) hear and decide on a request for a variance from the requirements of airport zoning regulations under Section 241.034, Local Government Code; and
- (4) perform other duties prescribed by ordinance or state law.

(B) The purpose of the Sign Review Board is to:

- (1) hear and decide a request for variance from the requirements of Chapter 25-10 (*Sign Regulations*);
- (2) exercise the powers to revoke or suspend a sign registration under Section 25-10-236 (*Revocation and Suspension*); and
- (3) advise the Council regarding Chapter 25-10 (*Sign Regulations*).

ARTICLE 3. MEMBERSHIP.

(A) The Board of Adjustment is composed of seven members appointed by the city council. The council may appoint any number of alternate members to serve in the absence of a regular member.

(B) The Sign Review Board is composed of nine members. The members and alternates of the Board of Adjustment shall serve as seven members of the Sign Review Board. Two additional members shall be appointed by the council under Section 2-1-181(A)(2) (*Sign Review Board*).

- 1 (C) A member that was appointed to the Sign Review Board serves at the pleasure of the city council. A
2 member that was appointed to the Board of Adjustment may be removed by the council for cause
3 on a written charge after a public hearing.
4
- 5 (D) Board members serve for a term of two years beginning August 1st on the year of appointment. A
6 vacancy on the Board of Adjustment shall be filled for the unexpired term.
7
- 8 (E) An individual board member may not act in an official capacity except through the action of the
9 board.
10
- 11 (F) A regular board member who is absent for three consecutive regular meetings or one-third of all
12 regular meetings in a “rolling” twelve month timeframe automatically vacates the member’s
13 position subject to the holdover provisions in Section 2-1-27 of the City Code, if the member was
14 appointed to the Sign Review Board, and is subject to removal for cause if the member was
15 appointed to the Board of Adjustment. This does not apply to an absence due to illness or injury of
16 the board member, an illness or injury of a board member’s immediate family member, or the birth
17 or adoption of the board member’s child for 90 days after the event. The board member must notify
18 the staff liaison of the reason for the absence not later than the date of the next regular meeting of
19 the board. Failure to notify the liaison before the next regular meeting of the board will result in an
20 unexcused absence.
21
- 22 (G) At each meeting, each board member shall sign an attendance sheet which indicates that the
23 member does not have a conflict of interest with any item on that agenda, or identifies each agenda
24 item on which the member has a conflict of interest. Failure to sign the sheet results in the member
25 being counted as absent and his/her votes are not counted.
26
- 27 (H) A member who seeks to resign from the board shall submit a written resignation to the chair of the
28 board, the staff liaison, or the city clerk’s office. If possible, the resignation should allow for a
29 thirty day notice so the city council can appoint a replacement.
30

31 **ARTICLE 4. OFFICERS.**

- 33 (A) The officers of the board shall consist of a chair and a vice-chair.
34
- 35 (B) Officers shall be elected annually by a majority vote of the board at the first regular meeting after
36 October 1st. In the event a current officer becomes ineligible to serve as an officer, the board may
37 hold an emergency election as needed.
38
- 39 (C) The term of office shall be one year, beginning November 1st and ending October 31st. An officer
40 may continue to serve until a successor is elected. A person may not serve as an officer in a
41 designated position of a board for more than three consecutive one-year terms. A person who has
42 served as an officer in a designated position of a board for three consecutive terms is not eligible for
43 re-election to that designated office until the expiration of two years after the last date of the
44 person’s service in that office. The board may override the term limit provision for an officer by an
45 affirmative vote of two-thirds of the authorized board members.
46
- 47 (D) A member may not hold more than one office at a time.

ARTICLE 5. DUTIES OF OFFICERS.

(A) The chair shall preside at board meetings, appoint all committees, and represent the board at ceremonial functions and approve each final meeting agenda.

(B) In the absence of the chair, the vice-chair shall perform all duties of the chair.

ARTICLE 6. AGENDAS.

(A) Two or more board members may place an item on the agenda by oral or written request to the staff liaison at least five days before the meeting. After first consulting with and receiving input from the staff liaison, the chair shall approve each final meeting agenda.

(B) The board liaison shall submit the meeting agenda through the online agenda posting system for each meeting not less than 72 hours before the meeting.

(C) Posting of the agenda must comply with Texas Government Code Chapter 551 (Texas Open Meetings Act).

ARTICLE 7. MEETINGS.

(A) The board meetings shall comply with Texas Government Code Chapter 551 (Texas Open Meetings Act).

(B) Board meetings shall be governed by Robert's Rules of Order.

(C) The board may not conduct a closed meeting without the approval of the city attorney.

(D) The board shall meet monthly. In November of each year, the board shall adopt a schedule of the meetings for the upcoming year, including makeup meeting dates for the holidays and cancelled meetings.

(E) The chair may call a special meeting, and the chair shall call a special meeting if requested by three or more members. The call shall state the purpose of the meeting. A board may not call a meeting in addition to its regular scheduled meetings as identified in its adopted meeting schedule, more often than once a quarter, unless the meeting is required to comply with a statutory deadline or a deadline established by Council.

(F) Six members constitute a quorum of the Board of Adjustment for purposes of hearing and deciding on appeals and requests for variances under Article 2, Section (A). Otherwise, a majority of the maximum number of regular members under Article 3 constitutes a quorum.

(G) If a quorum for a meeting does not convene within one-half hour of the posted time for the meeting, then the meeting may not be held.

(H) The affirmative vote of six members of the Board of Adjustment is required to grant an appeal or variance. The affirmative vote of six members of the Sign Review Board is required to suspend or

1 revoke a registration. Otherwise, to be effective, a board action must be adopted by affirmative vote
2 of not less than a majority of the maximum number of regular members under Article 3.
3

- 4 (I) The chair has the same voting privilege as any other member.
5
6 (J) The board shall allow any citizen to address the board on agenda items, except individual cases
7 under Article 2(A)(1) through (3) and (B)(1) and (2). If a citizen requests in writing that a matter
8 within the scope of the board's responsibilities other than a case under Article 2(A)(1) through (3)
9 and (B)(1) and (2), the staff liaison shall place the matter on the agenda within a reasonable time.
10 The chair may limit a speaker to three minutes.
11
12 (K) The staff liaison shall prepare the board minutes. The minutes of each board meeting must include
13 the vote of each member on each item before the board and indicate whether a member is absent or
14 failed to vote on an item.
15
16 (L) The city clerk shall retain agendas, approved minutes, internal review reports and bylaws. The
17 Planning and Development Review Department shall retain all official board documents. The
18 documents are public records under Texas Local Government Code Chapter 552 (Texas Public
19 Information Act).
20
21 (M) The chair shall adjourn a meeting not later than 10 p.m., unless the board votes to continue the
22 meeting.
23
24 (N) Each person and board member attending a board meeting should observe decorum pursuant to
25 Section 2-1-48 of the City Code.
26

27 **ARTICLE 8. COMMITTEES/WORKING GROUPS.**

28 COMMITTEES

31 (A) The Board of Adjustment and Sign Review Board will have no committees.
32
33 (B) Each committee must be established by an affirmative vote of the board. A committee cannot meet
34 until its creation is approved by the Council Audit and Finance Committee. Each committee shall
35 consist of at least three board members appointed by the chair. A staff member shall be assigned to
36 each committee by the director of the Planning and Development Review Department.
37
38 (C) The board chair shall appoint a board member as the committee chair, with the member's consent.
39
40 (D) A majority of the total number of appointed committee members constitutes a quorum.
41
42 (E) Each committee shall meet on a regularly scheduled basis at least quarterly.
43
44 (F) Each committee shall make an annual report to the board at the January board meeting.
45
46 (G) Committee meetings must be posted in accordance with Texas Government Code Chapter 551
47 (Texas Open Meetings Act).
48

1 (H) At each committee meeting, a committee member shall sign in on a sheet provided and shall
2 indicate that the member has no conflict of interest with any item on the committee meeting agenda,
3 or identify each agenda item on which the member has a conflict of interest.
4

5 WORKING GROUPS
6

- 7 (A) The board can determine the size of a working group but the number of board members serving on
8 the working group must be less than a quorum of the board.
9
10 (B) A working group may designate a chair, with the member's consent, but is not required to do so.
11
12 (C) Quorum requirements do not apply to working groups.
13
14 (D) Staff support will not be provided for working groups.
15
16 (E) Working groups are not required to post their meetings in accordance with the Texas Government
17 Code Chapter 551 (Texas Open Meetings Act).

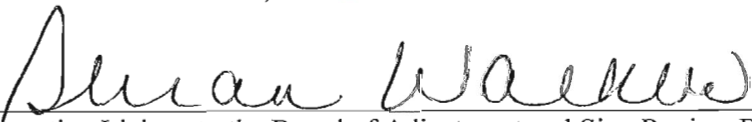
19 **ARTICLE 9. PARLIAMENTARY AUTHORITY.**
20

- 21 (A) Except as otherwise provided in this article, the rules contained in the current edition of Robert's
22 Rules of Order shall govern the board in all cases to which they are applicable, except when
23 inconsistent with these bylaws or with special rules of order which the board or city council may
24 adopt.
25
26 (B) The Rules of Procedure for the Board of Adjustment and Sign Review Board shall not be subject to
27 a motion to suspend the rules under §25 of Robert's Rules of Order.
28
29 (C) A matter that the board has reconsidered under Article 4(G) of the Rules of Procedure for the Board
30 of Adjustment and Sign Review Board is not subject to a motion to rescind or amend under §35 of
31 Robert's Rules of Order.
32

33 **ARTICLE 10. AMENDMENT OF BYLAWS.**
34

35 A bylaw amendment is not effective unless approved by the Council Audit and Finance Committee.
