Dear Mayor and Council,

As Chairman of the MACC Board I wanted to further correct and clarify the actual vote taken last night at our Board meeting in regards to the proposed renaming of the MACC in honor of Mrs. Emma S. Barrientos. The issue happened to be put on the board agenda one month ago for discussion only, but by coincidence the council renaming ordinance was scheduled for Council action this week. For the record, there was never any opposition from anyone on our Board regarding the name change; in fact all of us hold Mrs. Barrientos in the upmost regard and esteem and continue to respect her years of service and leadership to our community. The awkward part of our discussion was related to Chapter 14 of the city ordinance to rename a city facility and more specifically, that our board was unfamiliar with this language. In addition, for some, there was concern of creating a perception on potentially limiting public input and/or participation. The end result was a 4-1-1 vote to recommend that the city follow the renaming process including Chapter 14 of the ordinance. The vote was NOT to oppose the renaming of the MACC in honor of Mrs. Barrientos as misreported by the Infact Daily.

In retrospect, I do however want to go on record in stating that almost immediately following the unfortunate passing of Mrs. Barrientos, conversations within and among the Hispanic community were initiated regarding a potential renaming of the MACC in her honor. Over the course of this year, I have seen emails and social media entries demonstrating a strong support to rename the MACC in memory of Mrs. Barrientos.

Finally let me acknowledge that I am now keenly aware that the Austin City Council may exercise the right and power as elected officials to sponsor an ordinance and rename a City facility and I would personally offer my support to move forward with Item#33 to honor the memory and work of Mrs. Barrientos.
