In the action proposed, the Board will adopt the Operating Budget for Fiscal Year 2010 – 2011, beginning October 1, 2010, and ending September 30, 2011. Revenue includes \$983,069 in grant funding from the City in addition to \$1,330,094 of ad valorem tax revenue from Tax Increment Financing Reinvestment Zone Number 16. The proposed expenditures of \$2,377,143 from the Mueller Local Government Corporation include interest, principal payments, and administration costs.
