

M/WBE Summary

Bid documents were distributed to 15 general contractors. Bids were opened on August 5, 2010. The bid documents included three alternate bid items, one of which will be included in the contract. This alternate provides for 304 linear feet of 36 inch diameter storm drain pipe encased in 48" pipe at Highpoint Cove draining to Walnut Creek. Smith Contracting Co., Inc. submitted the lowest of 3 bids received:
