

ORDINANCE NO.

AN ORDINANCE AMENDING ORDINANCE NO. 20100927-05, WHICH ADOPTED THE MONTOPOLIS NEIGHBORHOOD PLAN AS AN ELEMENT OF THE AUSTIN TOMORROW COMPREHENSIVE PLAN, TO ADD TEXT AND A MAP TO THE PLAN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Ordinance No. 20010927-05 adopted the Montopolis Neighborhood Plan as an element of the Austin Tomorrow Comprehensive Plan.

PART 2. Ordinance No. 20100927-05 is amended, pursuant to File NPA-2010-0005.01 at the Planning and Development Review Department, to add text and map to Exhibit A (Montopolis Neighborhood Plan) of the ordinance, for a new Goal under Land Use regarding a hike and bike trail system known as the Montopolis Tributary Trail Network, identified on the attached Exhibit 1 to this ordinance. The new text and accompanying map begins at Page 14a of the Plan, as follows:

Goal 2a: Expand opportunities for the public enjoyment of Parks, Trails, and Open Space.

Objective 6a: Provide additional Open Space in Montopolis for public use and ensure that residents live in a clean and healthy environment.

Action 27a: Develop low impact public use features, such as recreational nature trails, on the 13-acre Watershed Protection Department property adjacent to the Frontier at Montana subdivision.

Action 27b: Mitigate solid waste, sewage, and soluble pollutant problems that impact our waterways, especially in the Montopolis Tributary of the Carson Creek Watershed.

Action 27c: Create an inventory of trees that are subject to restrictions on removal and cutting based on City ordinance guidelines.

Objective 6b: Increase the availability of Park land and diversify the ways in which Parks are used.

2 Action 27d: Designate more existing City of Austin property within the
3 MNP boundaries for potential use as Park land or for low impact
4 recreational purposes.

6 Action 27e: When feasible acquire additional land for the City of Austin to
7 be managed by the Parks Department or another City department for low
8 impact recreational purposes.
9

10 Action 27f: Create smaller "pocket" parks that serve localized neighborhood
11 needs.
12

13 Action 27g: Establish and maintain equity in the distribution of funds for
14 parks and public facilities.
15

16 Objective 6c: Establish hike and bike trails that provide connectivity within
17 Montopolis and to adjacent neighborhoods.
18

19 Action 27h: Develop the Montopolis Tributary Trail Network, a multimodal
20 hike and bike trail system that has a main route from the PARD Practice
21 Field at Felix and Vasquez, to East Riverside Drive near the site of the
22 proposed East Riverside Gateway Transit Plaza.
23

24 Action 27i: Develop a secondary route of the Montopolis Tributary Trail
25 Network from the main route near the Frontier at Montana subdivision to St
26 Hwy 183.
27

28 Action 27j: Where feasible, ensure that the Montopolis Tributary Trail
29 Network has multiple access points all along its routes.
30

31 Action 27k: Designate on-street routes connecting the Montopolis Tributary
32 Trail Network to other City of Austin Parks and trail systems within and
33 adjacent to the MNP including, but not limited to, Civitan Park,
34 Montopolis Park, Roy G. Guerrero Colorado River Park, Dan Ruiz Library
35 and the Lance Armstrong Bikeway/Trail.
