

ORDINANCE NO.

AN ORDINANCE WAIVING CERTAIN FEES, COSTS AND REQUIREMENTS FOR THE 2011 AUSTIN FARMER'S MARKETS, A CITY CO-SPONSORED EVENT, DURING THE 2011 CALENDAR YEAR.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The 2011 Austin Farmer's Markets, a City co-sponsored event per Resolution 021003-40 as revised by Resolution 20050324-040B, with the Sustainable Food Center, will be held at Republic Square Park and at the intersection of Triangle Avenue and 46th Street (bordering Triangle Park) on selected days during the 2011 calendar year. Food vendors for the 2011 Austin Farmer's Markets shall follow the guidelines and requirements of City Code Chapter 8-3 (*Restriction on Food, Beverage, and Containers*) and Chapter 10-3, Article 4 (*Mobile Food Establishments*).

PART 2. Council waives the following fees and charges for the 2011 Austin Farmer's Markets. Fees that have been paid shall be reimbursed to the Sustainable Food Center.
