

DOWNTOWN COMMISSION MINUTES

REGULAR MEETING WEDNESDAY, DECEMBER 15, 2010

The Downtown Commission convened in a regular meeting on Wednesday, December 15, 2010, at 301 W. 2nd St. in Austin, Texas.

Chair Mandy Dealey called the Commission Meeting to order at 5:32 p.m.

1. CALL TO ORDER AND INTRODUCTIONS

2. CITIZEN COMMUNICATION: GENERAL

There were no citizens wishing to speak on items not on the posted agenda.

3. APPROVAL OF MINUTES

The minutes from the November 17, 2010 meeting were approved on an 11-0 vote on Commission Haas' motion, Commission Member Leary's second, with Commission members Cady and Oveisi off the dais.

4. PUBLIC WORKS DEPARTMENT DOWNTOWN MAINTENANCE

Howard Lazarus, Director, Public Works Department, briefed the Commission on downtown capital projects and maintenance.

Rob Spillar, Director, Austin Transportation Department briefed the Commission on proposed changes to parking metering hours.

6. DOWNTOWN COMMISSION DRAFT TRANSPORTATION RECOMMENDATIONS FOR THE RAINEY STREET

Commission Members Cady and Knight recused themselves due to owning property in the Rainey Street area, and left the dais.

Lee Austin and Gordon Derr, Austin Transportation Department, briefed the Commission on responses to the draft recommendations.

Citizens Michael Abraham, Robert Icenhauer-Ramirez and Angela Hovis addressed the Commission on their concerns. Citizens Scranton Twohey and Jude Galligan were called up to answer Commission questions.

Robert Knight Stan Haas reported that the Downtown Development did not meet. Chair Mandy Dealey reported that Downtown Commission representatives to the Joint Urban Transportation – Downtown Commission Parking Subcommittee had previously been selected.
