## **REGULAR MEETING MINUTES** ***MONDAY, December 6, 2010***

The Art in Public Places Panel convened in a regular meeting on *Monday, December 6, 2010* at City Hall, Room 2016, 301 W. Second Street in Austin, Texas.

### **6. NEW BUSINESS**

- a. Presentation on PARD pool projects.  
Megan Turner introduced Parks & Recreation Department representatives Gary Gregson and Rey Hernandez and explained that the presentations would be for information purposes only,

no action required, and provided information on the AIPP funding available from each pool project.

Gary Gregson presented the plans developed to date for improvements to Barton Springs Pool. Panel members and staff briefly discussed options for location of art work, if all the projects could be grouped into one call for the multiple sites, and whether additional funding from the future projects at Barton Springs might be made available. Meghan Turner will research how the AIPP budget was determined and how the funding for this and the other pool project might be structured.

Rey Hernandez provided the presentations provided at public meetings for the West Enfield and Bartholomew pools. Neither project has been design yet. For both projects PARD would like an artist to work with the designers early in the process to integrate artwork into the design.

No action was required. Meghan Turner asked the AIPP Panel Members to consider options for how to orchestrate these calls to artists for discussion at future meeting(s).
